NARRATIVE

At approximately 1804 hours on January 18th 2025, I (Ptl. Tevoli #197) responded to Target (101 Grand Ave) for the report of a shoplifting. There I spoke with the loss prevention associate, Anthony Nishimura who wished

to report "2" shoplifting incidents that occurred on 01/12/2025 and on 01/16/2025. Both incidents involved the same suspect. Please see incident #25003652 for the initial shoplifting incident.

The second shoplifting incident occurred on January 16th 2025 where the suspect enters the store at approximately 1537 hours. The suspect is described as an adult black male wearing a gray GAP hooded sweatshirt. It is the same suspect from incident #25003652. The suspect selects the following items and places them inside a shopping cart.

1. Red Bull cases (Quantity 11 - \$225.39)
2. Cheez-it (Quantity 2 - \$12.38)
3. Milk (Quantity 1 - \$4.19)

Total retail value lost - \$241.96

The suspect exits the store at 1551 hours and passes all last and final points of sale without providing payment. The suspect is picked up by the same unknown make/model white sedan.
