NARRATIVE

At approximately 1804 hours on January 18th 2025, I (Ptl. Tevoli #197) responded to Target (101 Grand Ave) for the report of a shoplifting. There I spoke with the loss prevention associate, Anthony Nishimura who wished

to report "2" shoplifting incidents that occurred on 01/12/2025 and on 01/16/2025. Both incidents involved the same suspect. Please see incident #25003666 for the second of the two.

The first incident occurred on 01/12/2025 where the suspect enters the store at approximately 1051 hours. The suspect is described as an adult black male wearing a black Reebok hooded sweatshirt and a black down jacket. The suspect proceeds to select the following items and place them inside a shopping cart.

1. 3LB bag of oranges (Quantity 1 - \$3.99)
2. Men's pajama set (Quantity 1 - \$15.00)
3. Red Bull cases (Quantity 12 - \$245.88)

Total retail value lost - \$264.87

The suspect exits the store passing all last and final points of sale without paying. There is no known suspect vehicle expect the getaway vehicle being a white colored sedan. No known identity at this time.
