Attached is a list of current property owners and the on record owner addresses, highlighting any difference from the actual property location address. This list does not include larger commercial properties, vacant land, or exempt properties (excluding those of totally disabled veterans).

A difference in property location versus mailing address is not necessarily indicative of a rental, or owner non-residence, as it could reflect preferred PO Box, a Power-of-Attorney, a relative handling affairs for a resident, etc.

This list can be used in comparison to any known rental and registered landlord information that may be provided, but again will not be a 100% indicator of non-owner occupied properties.
