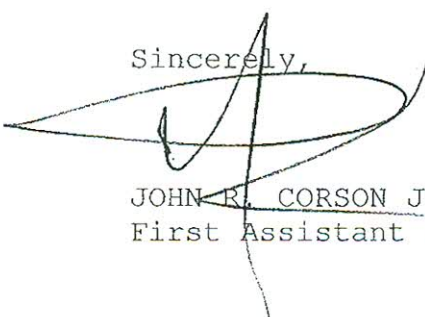
Re: Ocean County Recipient Voluntary Disclosure Program
