RYAN VACCARO, having been charged upon oath, before a Judge in the said County of Monmouth, with one count each of Possession of a Prescription Legend Drug, Possession of a Prescription Legend Drug with the Intent to Distribute, and Distribution of a Prescription Legend Drug, and having in writing, addressed to the Monmouth County Prosecutor, waived prosecution by indictment upon said charges, and said waiver having been duly reported and granted by the Court:

COUNT ONE

POSSESSION OF A PRESCRIPTION LEGEND DRUG

FOURTH DEGREE CRIME

The County Prosecutor of the County of Monmouth, alleges that RYAN VACCARO on or about and between May 1, 2018 and February 19, 2019, in or about the Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Possession of a Prescription Legend Drug, by knowingly possessing a prescription legend drug,

to wit: Clenbuterol, in an amount of five or more dosage units, where such substance was not lawfully prescribed or administered by a licensed physician, veterinarian, dentist or other practitioner authorized by law to prescribe medication, contrary to the provisions of N.J.S.A. 2C:35-10.5(e)(2), and against the peace of this State, the Government and dignity of the same.

COUNT TWO

POSSESSION OF A PRESCRIPTION LEGEND DRUG WITH INTENT TO DISTRIBUTE

SECOND DEGREE CRIME

The County Prosecutor of the County of Monmouth, alleges that RYAN VACCARO, on or about and between May 1, 2018 and May 11, 2018, in or about the Township of Ocean, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Possession of a Prescription Legend Drug with Intent to Distribute, by knowingly possessing with the intent to distribute a prescription legend drug, to wit: Clenbuterol, in an amount of 100 or more dosage units, unless lawfully prescribed or administered by a licensed physician, veterinarian, dentist or other practitioner authorized by law to prescribe medication, contrary to the provisions of N.J.S.A. 2C:35-10.5(a)(4), and against the peace of this State, the Government and dignity of the same.

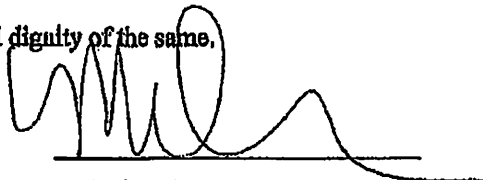
