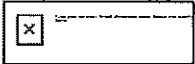

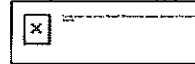

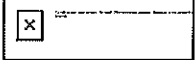

My name is Mohamed Radwan, 35, and in an effort to prevent what I am about to state from happening to someone else, I am compelled to share my story about a certain politician, Carteret Mayor Dan Reiman. I have been asked about Mayor Reiman my entire adult life.

During the time period from 1998 to 2014 Dan Reiman sexually harassed me. This took place on numerous occasions. I have lived with this for all of these years for fear of retaliation against myself and my family. Reiman had mentioned to me on several occasions that he said he would and I quote "destroy" anyone including their family, if they dared to challenge his position of power. I am now in a position in my life where I can come forward. Carteret is such a small community and I have a feeling that many people know the truth but are fearful to come forward for fear of some sort of retaliation. People that work in this town do not speak or say anything for fear of losing their or their family member jobs. Mayor Daniel Reiman has been mayor of Carteret for 16 years and rules with an Iron Fist. Also, Reiman keeps a secret that I and possibly a few others know. Dan Reiman is a sexual predator who preys upon under-aged boys. I know, because I have witnessed and experienced it myself.

From the 10 th or 11 th grade, I was groomed, sexually harassed (propositioned) over and over again by Reiman on and off for almost 20 years. I never thought it would be "normal" to talk about it outside my small circle of trust. Fear, guilt, humiliation and most importantly retaliation from the Mayor towards my immediate family always gave me the excuse to let this creep get away with what he did and I believe, still does today. Worst of all, I personally know other people who were victimized by this individual.

There were several reasons as to why I could not come forward earlier. Initially, I never expected to ever come forward. I feared that no one would believe my story; however, the most critical reason was the fear of Reiman targeting my mother, who was ill at the time, and my brothers, the way he targeted my father. I just could not live with the guilt of anything happening to anyone else in my family. When I learned of the Kevin Spacey story in which he was accused of seducing and sexual assaulting a 14 year old boy, it was an eye opener for me, as our stories mirrored each other.

It was when I was 15 or 16 years old that Mayor Reiman began soliciting sexual favors from me.

In the late '90s, Reiman communicated with me via America Online (AOL) Instant Messaging (IM).

During this time Reiman would:

1. Send inappropriate texts, videos, etc.
2. Ask for sexual favors and promise all sorts of jobs when he got elected Mayor.
3. Constantly try to grab my and other teenagers' private parts or expose his genitalia when others weren't around.
4. Demand sexual favors when I was in his car. Reiman would constantly solicit sexual favors with promises of a job in town for me or for others. When I was a minor, he would seek specifics about my sex life by soliciting photos and videos of me engaged in sex acts with either my girlfriends or me. I refused these requests every single time but he would consistently ask. This is very common among predators and sexual deviants known as "Grooming".

My closest friends witnessed these acts and to this day are fearful of what would happen if they came forward. When I decided it was finally time to talk about this, I met with a therapist. After explaining why I waited so long to come forward, I was advised to seek an attorney for my own protection. Since Reiman had an arsenal of attorneys, I found it difficult to find an attorney that could be trusted. I ended up finding an attorney located in Wildwood. After roughly 15 minutes with the attorney, he stated that all I had was a civil, not criminal, case. I ended our visit because I am seeking justice, not a quick pay off. In light of the most recent news reflecting the recent corruption in Carteret, I felt safe speaking to certain media outlets. I then met with Middlesex County Prosecutor Andrew Carey's office. I worked with his Lieutenant for several weeks. He stated that they were ready to go for a Grand Jury indictment but due to the Statute of Limitations (15 years) I was 2 years too late in reporting this; however, if any other victims came forward they could then re-open my case. After telling my story to the Lieutenant, he commented on how appalled he was for an elected official to behave this way and be in power for such a long time. His biggest concern seemed to be how many more victims are out there. Next, the media got involved. I met with many reporters for several months. The reporters met with several people to corroborate my story. When another victim, Pedro Morquillas (Carteret), (who in the summer of 2016 reported to the FBI how Reiman sexually assaulted him in 2007) seemed willing to come forward, the editors now wanted to publish a story. Pedro agreed to meet again with the media in twenty four hours to go on the record. I, nor the media, have ever heard from Pedro since. Coincidentally, shortly thereafter, Pedro landed a job with the Carteret Fire Department.

Mayor Reiman is a retaliatory type of person. Whenever someone opposed him he ensured there were consequences.

Here are a few examples:

1. Jim Failace is a former Carteret mayor who ran against Reiman. Reiman would fabricate damaging allegations against Failace in an effort to sabotage him and his family. Reiman felt politically threatened by Failace and also resented how well liked he was in town.
2. Fred Gerstler (VP of Board of Ed.), for not supporting Reiman's political party early on and, was falsely linked to Michael Jubanowski (Carteret Board of Ed.) who was convicted of theft from the Carteret Board of Education.

3. Reiman threatened small businesses or anyone who did not support him or contribute to his campaign with eminent domain.

4. Reiman would dissolve opposing unions by fabricating charges against them which forced them to spend large sums on money for legal counsel.

5. If there was a function in Carteret NOT hosted by Mayor Reiman, he would use his political influence to disrupt the event at local hall rentals. If his attempt was unsuccessful, Reiman would ask me, as well as others in his circle, to attend these functions and report to him who was in attendance. If there were individuals in attendance that he felt politically threatened by, he would have police officers staked out nearby and harass them as they were leaving.

When he was feuding with the PBA, he asked me to have my younger family members gather information of his political adversaries from social media avenues, such as Facebook, so that he could use this information against them. I refused his request. I would never involve my family in any of his diabolical schemes for fear that they, too, would be subjected to his abuse.

Here are a few examples of Reiman's union related antics:

1. Sue Ivanitski is a retired crossing guard (union member) who politically opposed the mayor, and as a result has been waiting 6 years for her pension.

2. Carteret Police Officer Jerome Mitchell, then PBA President, was serving on the Carteret Board of Education. His ideas differed from Reiman. Ultimately, Mitchell was arrested for domestic violence. Reiman told me that it was a setup and indicated that he was proud of it. The morning after the arrest Reiman called me and insisted that I read the local Home News Tribune while stating and I quote: "I finally got that N****R"! (racial epithet withheld)

3. Other Carteret union members who were victims of Reiman's retaliatory behavior are TJ Kaminsky (Police Officer), John Caldwell, Andy Tarrant (Police Sergeant) and my father.

In 2007, upon a return from a tour of duty in Iraq, Reiman appointed me to the Zoning Board. I started to once again be seen together with Reiman. People began to think that he and I were romantically linked, since there were rumors regarding Reiman's sexual preference. Townspeople even approached my father, a Carteret employee, and asked him to confirm the rumors. This angered my father to the point that he confronted Reiman. Reiman simply laughed at him and said and I quote "What are you going to do about it?" As a result of this altercation, my father severed ties with Reiman. Shortly thereafter, my father was terminated from his job and a series of erroneous charges followed. These charges would eventually be dismissed.

When Mayor Reiman's aide died, he would constantly solicit sexual favors from me with the promise of hiring my fiancée as the replacement. Subsequently, Michael Sica was hired as his replacement aide. Going forward, Reiman and Sica would taunt me with job offers claiming they would be available if either I perform sex acts on Reiman or my fiancée would perform certain sex acts with Michael Sica. It was so bad that I would sleep with my phone at night for fear my fiancée would see some of the inappropriate text messages sent by Reiman, via his borough cell phone. The more I tried to distance myself from the Mayor, the more he would harass and proposition me in my adult years.

It is important to note that my mother began to notice a change in Dan Reiman when I came back from Iraq. She no longer saw him as a positive influence and felt he was leading me down the wrong path. I opened up to her about the victims Reiman sexually assaulted but never mentioned my experiences. After seeing what my father experienced, I did not want to risk my mother or brothers becoming a target. I eventually moved out of Carteret, as my son was getting older and I feared that someday he would be a target.

I have observed that when in public, Reiman acted chauvinistically towards women, as a guise. When he started dating his girlfriend, he constantly sent me text messages claiming it was him and his girlfriend engaged in sex acts. These texts and videos were actually of him engaged in masturbation. Coincidentally, he got his first girlfriend when it was time for re-election.

In an effort to corroborate these facts, I took a polygraph test from a renowned Polygraph Examiner in the Tri-State area. I insisted that the examiner ask more than the standard two questions. I answered every question truthfully and a copy of the results have been made available to the proper authorities. I suggest Mayor Reiman take a polygraph test, if he is to deny any of these claims. This predator should never be around any teenager without proper supervision and hopefully someday will be punished for his sexual deviant acts.

Going forward, Reiman and Sica would taunt me with job offers claiming they would be available if either I perform sex acts on Reiman or my fiancée would perform certain sex acts with Michael Sica. It was so bad that I would sleep with my phone at night for fear my fiancée would see some of the inappropriate text messages sent by Reiman, via his borough cell phone. The more I tried to distance myself from the Mayor, the more he would harass and proposition me in my adult years.

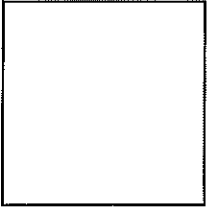

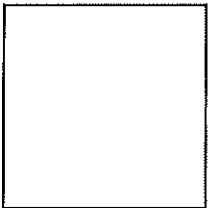
