Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On March 8, 2019, [REDACTED] came to police headquarters to provide a taped statement regarding an on going sexual harassment and sexual contact by her boss, Charles Bosco. [REDACTED] advised that on numerous dates, Bosco not only verbally sexually harassed her, but also touched her in a sexual manner. [REDACTED] advised multiple encounters with Bosco that she reported to be inappropriate. [REDACTED] stated that she was in Bosco's office explaining something to him that was on his computer. [REDACTED] stated that as she bent over to point at the computer screen, Bosco grabbed her by the back of her head and forced her head down to his genital area. [REDACTED] stated that her face touched his penis on the outside of his clothing. [REDACTED] stated that Bosco made a statement to her "While you're down there". [REDACTED] reported multiple other accounts of criminal sexual contact on diverse dates between July 2017 and August 2018. [REDACTED] stated that Bosco is spending unauthorized cash funds that were meant to be turned in to the Chief Financial Officer of Franklin Township to be entered in to the general fund Lt. Decesari and I responded Giordano's Scrap Yard and were provided with 2018 and 2019 receipts from the Township of Public Works scrap. A subpoena was issued for any petty cash records which I obtained on March 19, 2019. A check of those records revealed multiple receipts for cash expenditures at local dining establishments and retail stores.

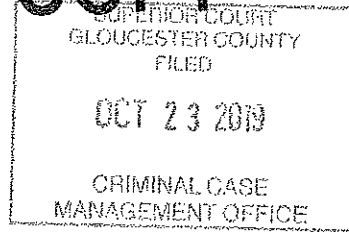

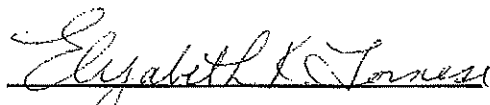

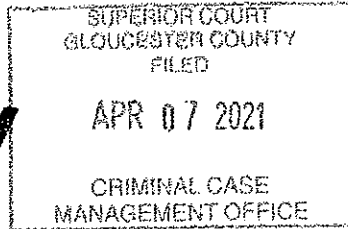
