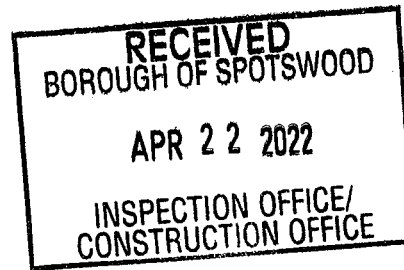

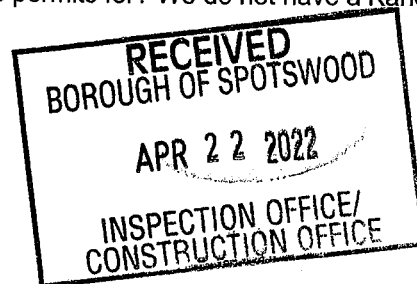
Pat,
