The Office of State and Local Code Inspections, Southern Regional Office, Division of Codes and Standards, Department of Community Affairs, is in receipt of your request for records under the Open Public Records Act (OPRA), regarding permits issued in the Borough of Englishtown.

In OPRA request tracking number C140791, information was requested to determine if there are open permits and/or permits for an underground oil tank pertaining to the following property:

- 14 Lasatta Avenue
Block 2, Lot 16
Englishtown, NJ 07726
- A thorough search was conducted of our records which discovered one (1) open permit: Permit ET 14-13012, for the replacement of a gas furnace, air conditioner and gas water heater, containing one (1) electrical permit, one (1) plumbing permit and one (1) fire protection permit issued to the property owner on 02/24/2014 and remains active.

Regarding your request for underground oil tank permits, this office took jurisdiction of Englishtown in 2007. No permits have been issued through this office for work pertaining to underground oil tanks. Permit 95-30 was issued in 1995 through Englishtown containing one (1) building permit. This file cannot be located and there is no description of the scope of work in the available database.

This office only issues construction permits for Englishtown. For information regarding liens on the property and remediation/environmental reports, please contact the Borough of Englishtown, the local health department and/or the New Jersey Department of Environmental Protection.
