You filed an OPRA request with the Department of Law and Public Safety (L&PS), Office of the Attorney General (OAG) seeking access to: "a data export from OPRA Central for the Attorney General's Office for the following fields from Jan 1, 2016 to Dec 31, 2017: name of requestor, date of request, date of response, request number."

As I read your request, you are seeking an electronic version of an OPRA report or log generated by the OPRA Tracking System ("OPRA Central") of all OPRA requests filed with the Office of the Attorney General over a two year period, specifically containing the following fields: name of requestor, date of request, date of response and request number. Between January 1, 2016 and December 31, 2017, a total of 565 OPRA requests were filed with the Office of the Attorney General.

I have explored the report and search functions of the OPRA Tracking System to determine whether the Tracking System could generate a report or a log which would fill your request. It could not. There are no reports or searches that can be performed in the OPRA Tracking System which capture fields indicating "date of response" or which sort data by "date of response". For that reason, the OPRA Tracking System can neither generate a report, nor create a log which contains the date on which each OPRA request filed with OAG was "completed".

For these reasons, OAG must deny your request.
