Dear Sirs:

Enclosed is the insurance form and addendums for it to start this process. I have more involved affidavits which detail the people's individual involvement in this awful situation. As the police surprised me by circling my property on April 29th, and chaining the doors up, while forcibly removing me indefinitely, no one could figure out why I was being subjected to this violence for no apparently good reason. The police had no court documents, no judgements, no warning letters, no real complaint to work from, nothing to justify their actions. It was as if they wanted me to file a complaint or charge them otherwise, which I am compelled, against my usual thinking, to do now.

It took me a full month to get the enclosed insurance forms, I came by the Clerk's offices five times, left messages on the phone and in person, requesting that these forms be sent to me, I was assured that they would be, I took afternoons to check mailboxes even. I became quite concerned about getting these forms in to you. Whatever else you need please write me directly, please do no contact other people about my submission. Contact me first. I have been running into problems with helper contractors acting on other people's direction, which they had no right to do. This has caused problems for me and the property. I have had bad neighbors, the ones working with the police, who have been trespassing. I will provide you with everything you need. All my communication means are working nicely, I prefer yahoo emails which reach me daily. I am seeking restraining orders now with a govt agency, not with attorneys, concerning these bad neighbors (Anglim, Daly, & Owens). This should calm everything down and I will begin work on repairs as soon as I can obtain compensation and get into the residence. I have been surviving on savings..and I believe Weehawken is responsible for serious damages to my home. I hope you will help me to straighten this out.

Thank you again for listening to my sordid story, the attorneys I work with are not involved with the insurance forms and I want to clarify that there is only ONE attorney that I work with there, Nicholas Fitzgerald ONLY. I do not work with any of the other attorneys and they should not be consulted (this includes a Goodman and a Lipnski). Nicholas is not involved in this situation except for a brief which is requesting general help and restraining orders. Do not contact people who claim to know me either, please speak to me first if you need more information.

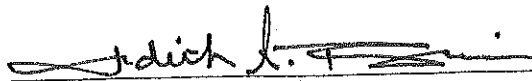

SUMMARY OF PERSONAL EXPENSES AND PROPERTY DAMAGES

This estimate is an early general one, to the best of my knowledge having repaired dozens and dozens of things in the house over the years, I am familiar with general costs of contractors.

AFFIDAVIT

STATEMENT This afternoon I was raking and picking up debris on my driveway, a task I accomplish often in warm months. This particular day, I was picking up and bagging small 1" rocks and other debris which was directly related to this renter-neighbors' remake of his driveway right before the winter, a few months before. I had in fact bagged, for this neighbor, John Anglim (wife Samantha), two huge bags of rocks – weighing over 50 lbs. each, small 1" rocks. These bags were heavy enough not be lifted, they had to be dragged across the lawn. This was his debris and it wound up on my lawn because his work crew had literally thrown these rocks over a 5' solid fence for them to land there and here I was cleaning his scene up. My lawn at this time was mowed and picked up, my bushes about to flower. Anglim had harassed and effected property damage to my residence in the past, heaving "debris fields" and weed seeds on the lawn area adjacent to his and my house. I did not have this problem any other place on my property. It was an irritating, consistent harassment connected to his property which was noticeable. I suspected that Barbara Tulko (relator managing Anglim's property or Barsa) or the Pomerance family from Manhattan (who knew me personally from the past and had an affiliation to other tenants of this property over time) were involved in this harassment. But Anglim was known for erratic and violent screaming fits on his lawn over trivial on nonsensical issues. His behavior was so menacing that I and other avoided all conversation with him at all. People called him "crazy," "nuts." This did not stop Anglim from tirades, he exploded without even a word from other people.

Further, the action coming in and out of Anglim's rental house, he had lived there three years only, was alarming. He had stewardess types, with overnight bags coming and going...late at night. He had a great deal of infants dropped off at the residence, week after week, the infants were screaming, not seen leaving the residence, just being dropped off. Cars would arrive daily, honking and dropping off the newborns, Anglim's lights in the basement were on 24 hours a day, cries and screams from the infants were heard throughout the first year from this house, and thereafter only muffled sounds from the basement. It appeared that the infant/children were being badly abused or dying. Large black garbage bags were seen being thrown quickly into trunks, taxis, as neighbors watched the cars sped off in great haste. Anglim also put out oddly weighted garbage bags minutes before Waste Management trucks picked up his garbage, making it difficult, if not impossible to check their contents. But, Anglim's erratic and violent screaming temper, his extreme anger fits, kept me and others from further questioning these other activities. One single word such as "hey" could set him off, he is such a menace in the area that most property owners avoid him altogether. His screaming fits appeared to be a cover-up tactic for the violence in the residence. Furthermore, it appeared that Anglim has police support against locals. Anglim's fits led to another incident with me two years before when the local authorities harassed me over something which also made no sense, as I questioned the baby-infant safety problem.

On this particular day, without warning Anglim exploded out of the back door of his rental and ran down the driveway to my surprise, screaming about the small 1" rocks scattered about his driveway, I told him they were HIS rocks, his renovation work from months before, only 5-6 of them. I was on my property with a 5' fence in between. I wasn't involved with his crew's work. I was about to heave the two huge bags of rocks his way though that I had graciously picked up off of my lawn, when he went into his usual tirade...and I told him to calm down relax, get it together, and another neighbor woman, a brunette in her late 20s, heard Anglim, and also told him he was nuts, crazy, YOU are a big problem she said, they both began screaming at one another. It was a wild and very violent scene, so I left the debris stone bags on my property and ran into my home. Two days later, on April 29, police arrived who were obviously involved with Anglim (joking with him, laughing, celebrating) and did significant property damage to my residence without provocation that I am aware of. The police electrically chain-sawed through my fence and chain-sawed three locks on my back door, as I was in the house, to violently break and enter my residence, claiming that I had a problem "chimney" which Anglim complained of. The chimney in question had no obvious loss of bricks or mortar whatsoever. It was backed up with a beautifully done tar covering on half of it, which I arranged, it was considered one of the nicest features of the house. It had made it perfectly through every hurricane ("Sandy" included) and had absolutely no problems, it was a necessary feature of the house which is used to vent appliances from the basement. The police then proceeded to tear the chimney down with the help of "Patrick's Construction" crew. Leaving a horrific mark on the roof, possibly with great damage to the roof. Further in a discussion on the phone with me, the Deputy Police Chief McClennan while this was going on said that he was very intentionally "building a case against me" for reasons unanswered. It was obvious he was referring to this incident as part of the case and I did not know who was behind this with him besides Anglim, the three police

officers and Frank Tatolli (Weehawken Building Departments Manager). The police told me several times over that Tatolli was the one who was "principally responsible" for this scene, he was the only one to speak to. There was no court action to support Tatolli and Anglim's actions in this case. They acted on their own, as a complete surprise, without any warning to me. My attorney heard the police actions ongoing on the phone on April 29th as he advised me, and he said that he had never heard of the police acting this maliciously or criminally or violently at "4 P.M. on a Friday afternoon when no court actions or professional action could be taken to halt them."

FACTS ABOUT MY RESIDENCE

1) **MORTGAGE PAID** The mortgage is fully paid, it was paid off to Washington Mutual in full, plus an extra \$15,000 in court costs, in March, 2010.

2) **TAXES PAID IN ACCESS** The residence is a ONE-FAMILY, not a two-family and has been such since 1981, with the exception of three years - 1993 - 1996. It has been taxed double during the time I have owned it. I have owned it from August 1993 - present, some 22 years. I paid full taxes, for a two-family home, to the extent of, on average \$10,000 per year, from 1993 - March 2010. That is about approximately \$170,000. Because I realized that I was way overpaying taxes, I stopped paying them in March 2010. ALSO, because it is a one-family, the police actions and building departments's actions were against the law.

3) **TOWN USAGE MINIMAL** The only city services I have ever used have been the parks and Waste Management, period. The taxes have been far far too large on my residence therefore.

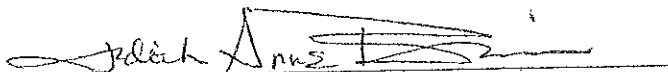
4) **VANDALISM MAXIMUM** The city council has been involved in using property taxes to vandalism targeted property owners, and these are by-and-large artist and/or Christians. It is so obvious it is almost not deniable by the outside of the residences. Barsa and Tulko, town relators, have also one tremendous damage to properties too as we have seen their signs go up on badly damaged homes and we have seen the houses badly renovated with sterile materials. This is an area of extreme criminality by the town counsel which is largely Episcopalian (Jewish/Golden Dawn) and Unitarian (Mormon) and therefore against Christianity. They are very prejudiced.

CONCLUSION This is an obviously criminal situation in Weehawken as this Anglim neighbor at 29 Duer goes on abated, with obvious police support, preventing me from either remedying or cleaning up the problems now in my residence. The police brought in a state "rescue agency" which killed my animals in May. I have been followed, stalked and harassed by Anglim's friends and yelled at in local businesses, talking about child kidnappings. I never used the word kidnappings in any conversation with anyone at anytime. Anglim needs investigation by criminal agencies, so do the police covering up Anglim's violent affairs. Anglim, I believe, is obviously involved in heinous crimes against infants and property owners in this township, so may be the police. State agencies need to be informed and action taken, thereof. There are many witnesses to these crimes in the local area whom I would like to suggest relevant authorities include in an investigation. It is not enough to push Anglim out of this township, he needs to be thoroughly investigated for whom he is involved with and how he came to move into this neighborhood. There is evidence that the Hyndman group (especially B. B. Hyndman, G. Hyndman and V.B. Hyndman), of Denver, my personal enemies, may be involved in these scenes. They also might warrant investigation and restraining orders as they were instrumental in staging another violent false pickup scene by police of me related to a first outburst of Anglim's temper in October, 2014. This follows a pattern as I also lost my animals due to a house break-in at that time. There have been these two incidents, 18 months apart which Anglim organized and was involved in. Renters in this particular house usually move every three years. Anglim needs much more investigation by the law.

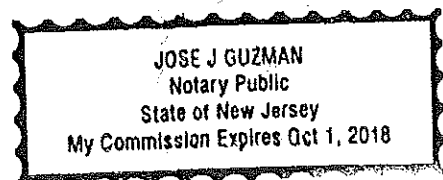

Dear Ms. Brundin:

This is to review some of the facts regarding your situation.

You have a terrible neighbor, John Anglin, who is a renter who has filed a harassment complaint against you in Municipal Court -- but right now that might be the least of your problems.

On Friday April 29th, 2016 the police arrived at your home in Weehawken, New Jersey. You were taking a nap. The police arrived at 2:00 p.m.. They banked on the door and they cut through three locks on the back door. They broke the hinges and they cut the chain lock.

They had cut through a chain on the driveway gate. They came onto the property unannounced. They showed a red building permit which said that "the premises must be vacated because there was an imminent danger due a chimney leaning slightly towards the center of the building." The chimney appeared to you to be in very good condition.

They had a construction crew on the site. The construction company is Patrick Construction Co., phone number (973) 303-6504.

You requested that the contractor examine the chimney to see its condition before it was taken down. The police told the contractor to take the chimney down. The chimney supports the entire house. If the chimney comes down it affects the structure of the building. They might well have done damage to the roof -- the roof leaks now -- before the chimney came down it did not leak.

The porch does need to be remodelled. They sprayed white powder all over the house including the front porch. They also sprayed white dust inside the house.

They had a building contractor with them. The contractor set up scaffolding right away - Patrick Construction Co. was the company.

You tried to simply walk away to speak to a neighbor. The

police stopped you from doing this. The police used their arms and elbows to push you around. They kept elbowing you -- harassing you and pushing you around -- not letting you talk to your neighbor.

There was a paramedic van about a block away and they forced you into the van. The van took you to St. Mary's ER in Hoboken. The doctor released you right away. They were both Asian men. You don't know the names of the doctors. They almost immediately released you from the hospital.

You then went to stay at a hotel.

You went back to the house on Tuesday evening, May 3rd, 2016, in a cab from your hotel. You walked up to the house to pick up mail and to examine the damage. It was dark. You got up on the porch to see if your pets -- birds -- were OK. They had put chains on the door and locked you out. You were worried about your birds. Two police cars showed up immediately. They had another paramedic van and they forced you into the second paramedic van -- this time they took you to the Jersey City Medical Center Emergency Room. This time they kept you in the hospital for about 16 hours! They claimed that you were "delirious" -- which wasn't true. You don't have the doctor's names but you think that you can get them.

On Thursday May 5th you arranged with Frank Rizzoli -- he is the director of the Buildings Dept for Weehawken -- for him to write up a temporary vacate order. His phone number is (201) 319-6057. He arranged for the 3 police officers to let you get a few personal belongings out of the house.

Your birds had been taken against your will and they were put into New Jersey Animal Rescue. You had spent four days trying to find the animals - You went to Lodai; to North Bergen two times; and to Cliffside Park looking for the animals. You finally found them.

On Thursday May 5, 2016 you were in the house for 20 minutes and the police told you that if you didn't leave, they would send another ambulance. You needed medications and electronics -- and you couldn't get your computer and keyboard.

The neighbor, John Anglin, who lives at 29 Dwuer Place -- is a renter and friends with the police. He has been a tenant for 3 years. He stands on the street screaming at people -- he screams at you and at neighbors. He screams at rocks on his driveway -- or he states that people are looking at his children -- his kids -- 2 boys -- one 2 1/2 and one about 6 or 7 -- he had his driveway redone and they put in a rock bed and he was complaining about rocks on his driveway -- and complaining about people not liking his kids or something.

Martin Latinsky recently learned that John Anglin has put in a criminal complaint against you in Municipal Court.

You believe, that John Anglin has conspired with the police to go after you. Based upon this Municipal Court complaint, you

might well be right about that.

As to the police entering your home, you believe that "hot shot photography" was used -- that is focusing the camera down in a certain way to make things look worse than they are --- and such photographs are not usually allowed in court.

You had spoken with Deputy Directly of the police -- William McClennan -- on the phone. His phone number is (201) 863-7680. Mr. McClennan told you that he was building a case against her for three months. He claims that you had enough time to fix up your porch.

The three officers involved are patrolman Edward Vion -- Badge 81; Sgt. Justin Rollings, badge number 83 and Chief William McClennan -- deputy police -- and boy does he scream on the phone.

WEEHAWKEN BUILDING DEPARTMENT'S IRONY

The building department's facility, the one it used for over 20 years located directly to the south of the City Hall building on Park Avenue, is in dilapidated, crumbling condition. It has been this bad for literally decades, this is not a new situation at all. F. Tatolli leveling direct criminal harm to property owners who have similar "vandalistic problems" in a township rife with these untold hits is certainly an act of hypocrisy.
