COMPLAINT AND JURY DEMAND

Plaintiffs, Rosanna Thompson and Oriandra Flowers; a Minor by her Natural Mother and Guardian, Rosanna Thompson, residing at 156 Chestnut Avenue, Apartment 1-F, Woodlynne, Camden County, New Jersey, by way of Complaint against the Defendants, say:

COUNT ONE

1. On or about May 6, 2016, Plaintiffs, Rosanna Thompson was the owner and operator of a motor vehicle and Plaintiff, Oriandra Flowers, a minor, was a passenger in the vehicle operated by Plaintiff, Rosanna Thompson.

2. On the aforesaid date and time, the Plaintiffs' vehicle was stopped at the stop sign on Richey Avenue at the intersection of Route 130 South, Collingswood, Camden County, New Jersey,

3. At said time and place, Defendant, James A. Cavanaugh, was the operator of a motor vehicle that was owned by Defendant, Borough of Collingswood, and was traveling on Richey Avenue at or near the intersection of Route 130 South, Collingswood, Camden County, New Jersey.

4. At said time and place, Defendant, James A. Cavanaugh, was acting as the agent, employee and/or servant of the Defendant, Borough of Collingswood.

5. At said time and place, Defendant, James A. Cavanaugh, did so carelessly, negligently and recklessly operate his vehicle by failing to observe the Plaintiff, striking Plaintiff's vehicle in the rear and causing a collision with the Plaintiff's vehicle, causing injuries to the Plaintiffs, Rosanna Thompson and Oriandra Flowers, a Minor,

6. As a result of the carelessness, negligence and recklessness of Defendants, James A. Cavanaugh and Borough of Collingswood, Plaintiffs, Rosanna Thompson and her daughter, Oriandra Flowers, a Minor, were caused to sustain diverse personal injuries, both temporary and permanent in nature; has and will endure great pain and physical discomfort; has been compelled, is now being compelled and may in the future be compelled to expend large sums of money for medical attention in an attempt to cure and alleviate their said injuries; has and will be prevented from attending their normal business and personal affairs; and has been otherwise damaged.

WHEREFORE, the Plaintiffs, Rosanna Thompson and Oriandra Flowers, a Minor by her Natural Mother and Guardian, Rosanna Thompson, demand judgment

against the Defendants, James A. Cavanaugh and Borough of Collingswood, individually, jointly, severally and in the alternative, for such sum as would reasonably and properly compensate them in accordance with the laws of the State of New Jersey, together with interest and costs of suit.

COUNT TWO

1. Plaintiffs hereby repeats each and every allegation contained in Count One of this Complaint and incorporates same herein for the sake of brevity.

2. At the aforesaid time and place, the Defendant, James A. Cavanaugh, was operating the aforesaid motor vehicle in the course of his employment or agency with the Defendant, Borough of Collingswood and John Doe(s) 1-5 (fictitious names as employers and/or principals of Defendant, James A. Cavanaugh), and therefore his acts of negligence are imputed to the Defendant, Borough of Collingswood and John Doe(s) 1-5.

WHEREFORE, the Plaintiffs, Rosanna Thompson and Oriandra Flowers, a Minor by her Natural Mother and Guardian Rosanna Thompson, demand judgment against the Defendants, James A. Cavanaugh, Borough of Collingswood and John Doe(s) 1-5 (fictitious names as employers and/or principals of Defendant, James A. Cavanaugh), for such sum as would reasonably and properly compensate them in accordance with the laws of the State of New Jersey, together with interest and costs of suit.

COUNT THREE

1. Plaintiffs hereby repeat each and every allegation contained in Count One and Count Two of this Complaint and incorporates same herein for the sake brevity.

2. Defendant, John Doe(s) 6-10 are persons whose identity or entities is not yet known who may be responsible for the accident and resultant injuries sustained to the Plaintiffs, Rosanne Thompson and Oriandra Flowers, a Minor.

3. As a result of the carelessness, negligence and recklessness of Defendants, John Doe(s) 6-10, Plaintiffs, Rosanna Thompson and Oriandra Flowers, a Minor by her Natural Mother and Guardian, Rosanna Thompson, were caused to sustain diverse personal injuries, both temporary and permanent in nature; has and will endure great pain and physical discomfort; has been compelled, is now being compelled and may in the future be compelled to expend large sums of money for medical attention in an attempt to cure and alleviate their said injuries; has and will be prevented from attending their normal business and personal affairs; and has been otherwise damaged.

WHEREFORE, the Plaintiffs, Rosanna Thompson and Oriandra Flowers, a Minor by her Natural Mother and Guardian Rosanna Thompson, demands judgment against the Defendants, John Doe(s) 6-10 (fictitious names as individuals who may be liable for the accident), for such sum as would reasonably and properly compensate them in accordance with the laws of the State of New Jersey, together with interest and costs of suit.

COUNT FOUR

1. Plaintiff hereby repeats each and every allegation contained in Count One, Two, Three and Four of this Complaint and incorporates same herein for the sake of brevity.

2. At all relevant times herein mentioned, the Plaintiff, Roseanne Thompson, is the natural mother and guardian of the minor Plaintiff, Oriandra Flowers. In such capacity, she has no interest contrary to that of the child.

3. As the mother and natural guardian of the minor Plaintiff, Oriandra Flowers, the Plaintiff, Rosanna Thompson, is responsible for any medical bills, treatment or other economic damage which the minor Plaintiff, Oriandra Flowers, was forced to incur as a result of the negligent conduct as aforesaid of the Defendants on May 6, 2016.

WHEREFORE, the Plaintiff, Rosanna Thompson, seeks damages, interest and costs for such sum as would reasonably and properly compensate her in accordance with the laws of the State of New Jersey.

COUNT FIVE

1. Plaintiffs hereby repeat each and every allegation contained in Count One, Two, Three and Four of this Complaint and incorporates same herein for the sake of brevity.
