On the night of 8-28-14, between 7:40pm and 7:45pm I was at work, (Simon & Schuster) located in Riverside, NJ. I was working in a office area on first floor when I noticed a Delran Cop drive in to the parking lot on Front Street. I left the office area at 8:02pm I clocked out at 8:03pm. The Delran Cop was parked in the parking lot when I left the office. I was parked on brown street parking lot. I sat in my vehicle in the parking lot until about 8:30pm eating my lunch. I have another job I go to at 9:30pm. I drove out the parking lot turned left on third street to Chester ave. At Chester ave I turned right. As I drove on Chester ave I looked in my rear view mirror looking for the Delran Cop. I noticed a car turn off front street on to Chester ave. I watched the car as it picked up speed driving toward me. Two cars was in back of me. Both cars turned off Chester ave before I got to Route 130.

Officer 2308 got behind me on Chester after the two cars in back of me turned off Chester ave. I stopped at the red light before turning left on Route 130 North. On 130 I drove through two lights on green, breaking no law before Officer 2308 put her lights on to stop me. Officer 2308 had no legal reason for stopping me. I asked officer 2308 why did she stop me? Officer 2308 asked me for my driver's license, registration and insurance card. She walked back to her car. A Delran Cop in a SUV drove up behind my vehicle. After about ten minutes Officer 2308 walked back to my vehicle gave me a ticket for unclear Plates. I said to her, there was nothing wrong with my license plates. I got out my car walked to the back of my vehicle.

I asked officer 2308 to show me what's wrong with my license plates. Officer 2308 said the dealer bracket around my license plates is what the ticket is for. I told officer 2308 that the bracket around my plates have been like this for over two years and I have never received a ticket. Exhibit A-1 a picture of my license plate. Exhibit A-2 is a copy of the ticket. I told officer 2308 that I saw her drive into the parking lot on front street. I told officer 2308 that she waited for me to leave work and followed me. This is the second time officer 2308 has stopped and question me. On January 10, 2014 after 8:00 pm I was leaving work when officer 2308 was waiting on third street behind a store. I was questioned about where I'm coming from.

Officer 2308 was present on another time when I was questioned by Delran Police on April 25, 2014. Officer 2308 had no legal reason for stopping me on 8-28-14, and 01-10-14.

This is harassment. On several occasions Delran Police has waited and followed me before and after work. I have listed dates on Exhibits B-1-3. On several occasion when leaving the parking lot on brown street I have been harassed by individuals waiting in cars following me calling me the N-word.

I have listed Exhibit C-1-b. I have complained to Human Resource at Simon and Schuster about this and about harassment from law enforcement for over eight years. Also I complained to the Lawyer for CBS -(they own Simon and Schuster), about harassment from law enforcement for over eight years.

This is on record that I complained.

Every where I have worked and lived over eight years this has followed me. The same hatred and harassment from police. There is nothing I'm doing illegal. I have been harassed by nothing but white cops. I believe this is racially motivated. I have the same rights as every body else in this country.

I bought a new vehicle over two years ago. I have had over 60 jump starts on this new vehicle. I can't get anybody to tell me what causing my battery to go dead. I believe some kind of GPS system is on my vehicle

I had the exact same problem with two other vehicles I bought since this harassment started. When I go out of state I have been followed and harassed by police. I have listed on Exhibits D-1-3. the jump starts.

Law enforcement has gotten away with harassing me for over eight years. I have nothing but distrust in the police and the legal system. When I told officer 2308 I was going to file a Complaint against her, "She told me she didn't care." I went to court 3 times for this case, because Delran kept pushing the date back. I went to court December 3, 2014, the case was dismissed. During all this time, Delran and other Township Police including State Police has been trying to get something to use against me. I have been followed and stopped by State police on Route 130 N when going to my second job. Harassed by other police and stopped. I was late for work when stopped by officer 2308 and when stopped by another township.

I was driving a rental car for about 2 weeks. I was harassed the 2 weeks I had the rental car. Police is watching me every morning when I leave work. They are parked at the corner outside my second job every morning. I have been questioned when leaving work. I'm dealing with hatred from individuals some mornings when leaving work. I have been harassed by white cops for over eight years. They don't have a single thing to justify following me for over eight years.

4. July 31, 2012 - Delran Police in an unmarked tan car followed me after work after 8:00pm. I stopped to get gas on Route 130, the cop waited.
5. August 22, 2012 - Delran cop unmarked car, same unmarked car waited for me to leave Wawa on Route 130 at 2:50 pm. Followed me when I left Wawa.
6. September 4, 2012 - Delran Police was waiting for me after 8:00pm when I left work. Followed me.

7. September 17, 2012 - Delran Police followed me to Home Depot After 2:00pm, waited for me to leave at 3:30 pm.
8. October 3, 2012 - Delran Police waited across street from Public Storage after 8:00pm came over after 9:00pm when I was in front parking lot.
9. October 21, 2013 - Delran Police followed me after 8:00pm leaving work.
10. October 23, 2013 - Delran Police followed me after 8:00pm leaving work.
11. November 21, 2013 - Delran Police followed me after 9:00pm after work.
12. November 22, 2013 - Delran Police followed me to Wawa 3:00pm, waited for me to leave.

15. April 25, 2014 - I was Parked in the Parking lot off Chester ave and Route 130 where Wendy's is located after 3:00pm before work. Delran Police harassed me for Parking there. Officer 2308 was one of the cops that was there.
16. July 02, 2014 - Delran Police followed me after 8:00pm when leaving work.
17. July 21, 2014 - Delran Police followed me into Parking lot where Wendy's at after 3:00pm. Waited for me to leave.
18. August 14, 2014 - After 3:30pm Delran Police waited for me to leave Parking lot where Wendy's at. Followed me to work.
19. November 3, 2014 - Around 3:45pm I was drivin to work on Chester ave. Riverside Cop put his emergency lights on to stop traffic, so that he could get behind me. He followed me up Chester ave

I have listed here dates of when I was harassed by individuals waiting on Brown Street when I drove out of the Company Parking lot. I was called the N-Word on several occasions. I reported this to Human Resource at Simon and Schuster.

1. June 18, 2012 - I drove out of the Company Parking lot after 8:00pm. I was followed by a car on brown Street. I turned on to 3rd Street. The car behind me was closed behind my vehicle. The individuals was yelling the N-word at me as I drove toward Chester Ave.
2. July 13, 2012 - After 8:00pm I was leaving work. A car was parked on brown Street across the street from Simon and Schuster with their lights on. I was followed by this individual. I turned on to 3rd Street and stopped on the side of road. The car stopped behind me. Someone shouted N-word for me to go home.

The individual followed me to Chester ave. I turned right and they turned left.

3. September 11, 2012 - After 8:00 pm as I was leaving work, I turned on to 3rd Street a SUV followed drove up next to my vehicle on 3rd Street. Two individuals yelled the N-word at me and drove off.

4. September 28, 2012 - AS I was leaving work after 8:00 pm, I pulled over to the side of road on brown Street. I stopped for about ten minutes. Two cars drove by with individuals yelling the N-word at me.

5. October 18, 2012 - AS I was leaving work after 8:00 pm. I was on 3rd Street driving toward Chester ave, a car drove up fast behind me. A individual was calling me the N-word. The car followed me on Chester ave to Route 130.

6. November 06, 2012 - After 8:00 pm I was at the corner of 3rd and Chester ave, a car was waiting in the parking lot at the store. The car followed me to Route 130. The individual pulled up beside my vehicle at the red light called me the N-word.
7. January 11, 2013 - After 8:00 pm I stopped on the side street of brown. I was checking my phone, when several white teenagers walked by my vehicle called me the N-word.
8. MARCH 22, 2013 - After 8:00 pm as I was leaving work, I drove pass a car parked on brown with their lights on. The car followed me to third street. The individual turned on his high beam lights, then started calling me the N-word.
9. April 19, 2013 - After 8:00 pm as I drove out the parking lot on to brown street, two cars followed me to third street. Both cars passed me on third street, individuals calling me the N-word.
