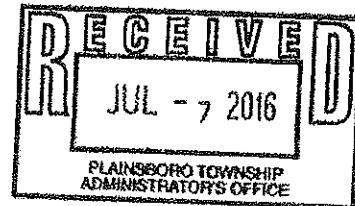

3. CIRCUMSTANCES REGARDING THE OCCURRENCE OR INCIDENT:

5. LEGAL GROUNDS FOR CLAIM:

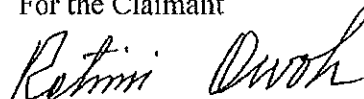
- a. Negligence

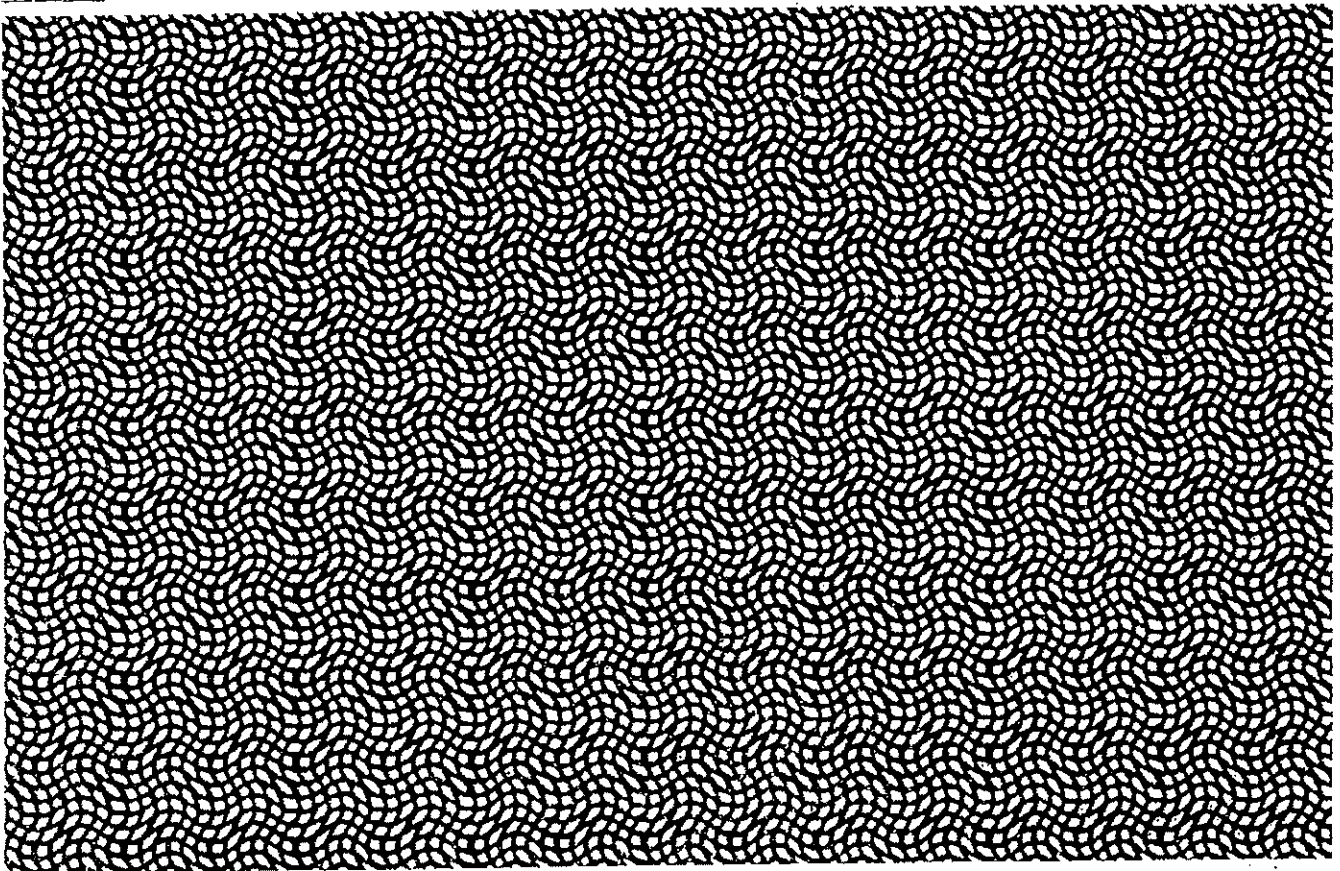

Dear Rotimi,

Records indicate that on 05/26/2016, you were arrested for Driving Under the Influence. Intoxalock will help you regain your driving privileges with the installation of an ignition interlock device (IID).

If you have a court order or required by the Motor Vehicle Commission (MVC) call (888) 417-0455 in order to install your IID and satisfy your requirements as soon as possible. If you do not install an IID it could result in loss of driving privileges.

To regain your driving license you will need to:

1. Follow instructions on the notice of suspension from the MVC
2. Install an ignition interlock device (if required)

6. Complete Intoxicated Driver Resource Center (IDRC) requirements
