Affidavit of Fact

On 6/30/2017 At approximately 1246am I was driving west bound on racetrack rd. and came to a complete stop at a red light at the corner of rt. 18 and racetrack rd. I was in the right lane with my right signal on and facing westbound on racetrack rd. As I waited to turn right on rt 18 north bound, I noticed two vehicles traveling north bound on 18 and which I believed was a 1994 Honda/ Toyota and traveling right behind that car was a black truck/jeep east Brunswick police vehicle (which I later found to be driving was officer Christopher Williams). As the two vehicles passed I proceeded to make a right on rt 18 north bound and headed straight. I noticed officer Williams make a right on the jug handle of Arthur st and came to a stop at the red light facing towards rt. 18. I thought nothing of officer's Williams action at that specific time. I continued to proceed to go through the light of Arthur st. heading north bound and put on my right turning signal to go into the Exxon gas station. As I was getting gas I noticed that officer Williams didn't move from where he had initially stopped at the red light even after the light had turned green. This puzzled me especially after the light turned red all over again, I then thought to myself that maybe officer Williams maybe conspiring/ planning to pull me over or someone else over. So as I finished getting gas I proceeded to exit the gas station at the proper exit way, turned on my signal to turn right onto the highway and proceeded to travel north bound on 18, traveling at the proper speed limit. I noticed in my rear view that as I turned onto Rt 18 officer Williams finally decided to make a right onto rt 18 as well, I then came to the conclusion that the whole time officer Williams was at the light he was definitely planning to pull me over.

(which leads me to believe he had no other intentions but to harass me and racial profile me, reason being I did not commit a crime nor was there a crime being committed or in the process of being committed. Furthermore at time of the night there were no cars so there could not be any unsafe lane change or merge from a driveway or alley especially coming out of a gas station where the road was completely deserted at that time. The frivolous claims that he is raising are all excuses to make an illegal

stop to harass me and check my credentials to see if he could find a charge/ claim to give me a ticket of some sort. The allegations that is made does not make any sense logically or lawfully. Which also leads me to believe he must be extremely uneducated when it comes to the law and secretly racially bias to minorities in a better position than him financially and or at an educational stand point, this is where a lot of his anger emotions reflects his false judgments while on duty and not from law. In addition he knows himself that there was no traffic violation (such as a seat belt/unsafe lane that could possibly have occurred at this time of night).

So as approached the landmark of taco bell officer Williams accelerated well beyond the speed limit to catch up to me, he then turned on his emergency lights to signal me to stop. So I cooperated and put my right blinker on and pulled over, he directed me through the loud speaker and told me to make a right turn on a dark and secluded street right next to taco bell (Fountain Street). As I did so, I then turned off my car and put my keys on the roof of the car, put down all my windows and placed my hands on the steering wheel. Officer Williams approached my driver side window very aggressively and loudly asked me "do you know why I'm pulling you over". I told him "no I don't and what was the probable cause for you doing so." He told me that "when I passed you on race track rd. you didn't have your seat belt on," I told him that "you are wrong and I did have it on and I still do, also how could you have allegedly seen me with no seatbelt going 20 to 30 miles pass me. It does not make any sense" and I also asked him "why didn't you just stop right then and there to pull me over, why would you wait and try to pull me over approximately 10 min later." At this point officer Williams became very upset and enraged that I challenged him, and he told me to give him my ID, registration and insurance. I did so with no problem. After he went and checked my credentials I knew he was upset that I didn't have any

warrants, license suspension etc... to give him any further excuse to abuse his power of authority. He then proceeded to ask me all these irrelevant questions not pertaining to the initial traffic stop at all. He asked me where was I going?, did the car belong to me?, when was the last time I got pulled over? , all unnecessary questions only to harass me and abuse his power. He raised his voice at me in a very irate manner and conducted himself in a very poor manner while initiating his illegal traffic stop. Then Officer Williams waited till his partner arrived and proceeded to ask me to step out of the car. I asked him " why do I have to get out of my car and for what, I have not committed any crime" he yelled again and asked me again can I step out the car ". I said "for what, I didn't do anything", So I cooperated and stepped out of the car he told me to go to the back of my car and put my hands on the trunk, so that he could search me for weapons. I expressed to officers Williams that I do not have any weapons and I do not consent to any searches. I asked him why would you pull me out of the car to conduct such investigation for a seat belt ticket. Officer Williams disregarded everything I said and proceeded to still conduct a stop and frisk, with no probable cause to do so (trying to turn an alleged traffic violation into some type of crime investigation). I again told officer Williams that I do not consent to any searches and he ignored my command. So as he frisked me, he continuously rubbed my genitals and bottom as if I was a female he was about to penetrate. He did so in a way that his partner could not see. These homosexual gestures had me very uncomfortable, violated, unsafe and afraid. He clearly violated my constitutional rights specifically the fourth amendment, due to the fact he didn't have probable/ lawful reasoning to even stop and frisk me in the first place. Especially when there was no crime at foot or in the process of being at foot. He misconducted himself not only by conducting an illegal traffic stop, but by acting way outside of his official duties as an East Brunswick police officer while violating the police code of ethics. He treated me as if I committed a crime, he harassed me by holding longer than needed to be asking irrelevant questions and by under threat, duress and coercion, he failed to answer any lawful question (that I had a right to ask him) that I raised to him about the reason for him pulling me over and

instructing to me to get out of the car. Officer Williams wanted to inflict fear into me by forcing me to step out of my vehicle and alleging that a traffic stop turned into an investigation which, all ended in 3 frivolous complaints/summons about accusations he has no proof of! He failed to answer questions I had for him and made racial slurs to me under his breath specifically by saying ("how did this NIGGER get this car!") I continued to ask him what was the probable cause and he then started to tell me that he didn't have to tell me anything and that it didn't matter. This type of homosexual, racial profiling, harassment behavior is unacceptable and will be brought before a higher tribunal to deal with the misconduct of officer Williams actions.

Additionally, when officer Williams didn't find what he was aggressively and forcefully looking for he became upset and started to circle my car "like an irate k9" shining his light inside of my car and trying to find something so that he could make an excuse to continue to prolong my alleged traffic stop. Officer Williams had no right placing his hands on me or my property because he did not have a warrant/ probable cause to do so, he grabbed me by the leg very sexually while he was frisking me and under the united states constitution and the state of new jersey constitution, this falls under the category of assault. So after that, I demanded to speak to his superior and at first he denied the command and then later said that he would call him. As I waited another 15 20 min his boss finally showed up . I explained my position of what the problem was and that I felt that I was in danger due to the secluded area we were in and my cry for help was denied. His boss told me that it seemed like to him I was mad I was summoned to court. I then realized that his boss didn't want to incriminate his fellow worker due to his loyalty to him and also covering up for his workers misconduct because everything was being recorded. His boss disregarded my factual statements and that is when Officer Williams gave me the summons and I told him I will see him in court. With Officers Williams doing all this supposedly police work, wasting the money of East Brunswick tax payers, there were true crimes

happening at that same moment. Officers Williams is a disgrace to the East Brunswick police department and a undercover racist and homosexual, the statements that I am making are true and factual, because I personally experienced it on this day of 6/30/2017 and can be backed by firsthand knowledge under penalties and perjury! This is unacceptable to me and also other men within the township of East Brunswick and I will take this matter to the full extent of the law until it is completely reconciled!
