On June 20th 2014 approximately 9Am Edison NJ 07217 at 127 Marina Dr Apt J, New Brunswick Prosecutor's office and Edison Police Department acted under the color of law, Violating my rights to the U.S Constitution Forcefully invited themselves into my home without presenting/issuing any type of Search Warrant or Complaint Warrant, made duress and racial comment while being a tort arrested I was never read my Miranda rights nor gave officers my consent for searching my persons while being forced into the rear of the officer's car I asked several times "What am I being detained for?" and no one respond. Upon my arrest I was never given a Complaint/Warrant, days later while being detained at Middlesex County Adult Correction Center I was brought to an in-house court arraignment in this center to find out that I was being charged with Complaint No. 707-1205 with a bond of \$200,000.00. I am still being held captive for these false allegations which violates my 4th, 5th, 14th, 2nd and 19th amendments to the U.S Constitution. I was revealed at court on Aug 22nd 2014 that the Prosecutor had no other statements only Police reports of these accusations Comp No. 707-1205. So I in turn wrote a formal request to exercise my 5th and 14th Amendments and to be present for the grand jury procedure hearing to face my accuser only to find out that Middlesex County Judicial system does not abide by the U.S Constitution Amendments by telling me that I cannot be present for my grand jury procedure hearing to face my accuser. On July 31st I submitted a tort claim against the New Brunswick Prosecutor's office, Edison Police Department and Middlesex County Adult Correction Center for: A tort and false imprisonment against my will which caused mental anguish of my mother, wife & livelihood, family, kids, my father's ashes and everything he left after his

death on April 2nd 2014, Duran and racial comments, My life being at risk/Jeopardy
due to me having to put up arguments with Correction Officers some
most nights just to get a breathing treatment due to my bad asthma,
\$300 Cell Phone, and for lack of corpus delicti.

Thank you for your time and patience and I pray you will
take demand of my Civil Suit.

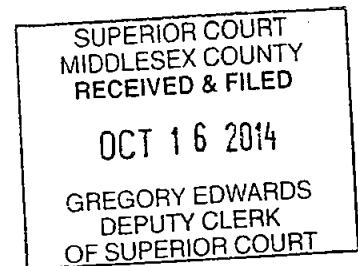

On 6-22-2014 approximately 9am Frank Varga (FV) from New Brunswick Prosecutor Office and (3) Officers from Edison Police Department banged on my door where I once reside at 127 Marina Dr Apt J Edison NJ 08817. When my sister quiteplcate "Who is it" Officers did not respond and kept banging. When she unlocked the door and was about to peck at to see who was doing the banging Officers then forcefully pushed her out the way while making there way into my home not knowing if I was either home or not, Officers began to search not saying one word. I heard my sister say "Hey you can't come into our home without an Search warrant, let me see a warrant" but officers never respond and kept searching room to room. Once officers located me in one of the two bedroom at the rear of my home still laying in bed from the night before with my Cell Phone in hand trying to call my mother to let her know what's going on but never got the chance to connect the call because officers jumped on top of me taking my phone using so much force while putting my hands behind my back it felt like my arms was going to break. I kept yelling and screaming Stop Help Help Stop I'm not resisting your hurting me Officers then told me to Shut the F**k up. I felt like crying because i was in so much Pain due to Officers conflicting so much force I did not know who to turn to for help. As Officers placed handcuffs on me, Searching my Persons which I have not given consent for them to do so, and allowing me to slip into my sneakers I then look up to see (FV) going throw my phone and (FV) says "It's clear he didn't have a chance to call or record so we're good". One of the (3) officer's say's "Cool". As soon as (FV) turns my phone of my sister then asks for my phone, Search Warrant, arrest Warrant, and

Complaint Warrant. By this time you can tell that (FV) was vexed by the look on his face, the tone in his voice, and by the way his skin color changed. (FV) Says No... and we don't need a Warrant to come get this nigger, and if you bring it up in court I'll just say you invited us in. Me and my Sister look at each other with Shock that an Officer would make a comment like that. So I asked what am I being arrested for and (FV) tells me to shut up. My Sister Says "I will bring it up because you can't do this you pushed me and you need some type of Warrant". (FV) Says "go ahead court's won't believe yall and if yall do bring it up there will be repercussions, so what do you think about that" by the look on my Sister's face I can tell she felt hopeless for the both of us by the Duress (FV) made. then Officer's and I went to the car. Day later on June 24th 2014 9am at an inhouse court arraignment here at Middlesex County Adult Correction Center I then find out that I am being charged with Complaint No: W14707-12C with a bond of \$200,000.00 and currently still held captive for these false allegations. Which violates my rights to the U.S Constitution 4th, 5th, 6th, 8th, and 14th amendments. On July 31st I submitted a tort claim against Middlesex County Prosecutor Office, Edison Police Department and Middlesex County Adult Correction Center for: Duress and racial commor \$300 Cell Phone; Violating my rights to the U.S Constitution, lack of corpus Delicti, False imprisonment against my will; my life being at risk/loss due to my Asthma, mental anguish of my well being, loss of livelihood, family, kids; My father's ashes... etc. On August 22nd 2014. I was revealed at court that Prosecutor only had Police reports and no other statements which was made from me and my father in Nov 2013. So I in turn wrote a formal request on 9-10-2014 to exercise my 5th and 6th amendments and to be present with my attorney for my grand Jury Procedure hearing to face my accuser only to find out that Middlesex County Judicial System does not abide by the
