My name is Cheng Chung Hsu. I am the driver of one of four cars that was involved in a multi car accident that occurred on September 27, 2016 at the intersection of King George Road and Route 22 in Green Brook, NJ around 1:05 PM. Green Brook Police Case number is 1622-3636. I want to sue Mr. Rigoberto Gonzalez who works at 109 Greenbrook Rd, Green Brook Township, NJ 08812.

I have been driving for over 35 years in NJ/NY/OH/Texas/Oklahoma. I have never hit any car from behind and I have never been involved in any car accident in the past 10+ years. I am suing Mr. Rigoberto Gonzalez, the police officer, who fabricated untrue information in the police report on the aforementioned car accident and drew inaccurate and unfounded conclusions in the report.

Mr. Gonzalez's inaccurate and biased police report has caused me to miss out on a fair investigation from my car insurance company. Furthermore, I suffered financial losses because of Mr. Gonzalez's lying actions amount to a \$500 dollar deductible that I must pay, an increase in my car insurance premium in the next 5 years, and a bad driving record.

I am suing Mr. Gonzalez for \$15,000 as his biased and erroneous police report has caused me to suffer significant monetary losses. In addition to these monetary losses, Mr. Gonzalez's actions at the scene of the accident and his interactions with me afterwards show ill intent as I was treated unfairly with bias.

1) Mr. Gonzalez's fabricated untrue information

My statement to the Mr. Gonzalez at the scene is "I hit the car in front of me because the car behind mine hit my car and pushed my car into the car in front of me. My car was at a complete stop as I waited for the light to turn green."

Officer Gonzalez's report indicated that I stated "I was slowing down and hit the car in front of me". This is totally untrue as I never said that. This officer lied in the report.

2) Mr. Gonzalez lied in front of me and my wife

Officer Gonzalez clearly stated that he was only at the scene to take statements from each of the drivers, and not to make any judgment about what had happened. That was the reason why he separated four of us to take statements. He clearly stated that it is insurance company's job to investigate and make decision as to who is at fault. But he clearly did make an incorrect and unfair judgement in the report.

3) Mr. Gonzalez's unfair and/or incorrect judgement

Mr. Gonzalez made an unfair and/or incorrect judgement-- that I hit the full size SUV at high speed all by myself, based on only two pieces of information.

- i. There was only minor damage on my rear of the car.
- ii. There was severe front end damage on my car and my car was totaled.

Mr. Gonzalez drew an erroneous conclusion without taking into accounts of the following list of facts:

A. Reason for the observation "There was only minor damage on the rear of my car".

- 1) This is because it is a bumper to bumper collision. The bumpers absorbed a large portion of the shock. Furthermore, the collision of the much larger vehicle from behind caused my car to move forward, further absorbing the shock of the rear collision.
- 2) Bumper to bumper collision is mostly elastic collision in physics that all the energy is passed on to the next object. This force will be passed on and on until the force is worn out.

B. Reason for the observation "There was severe front end damage on my car and my car was totaled".

- 1) The car in front of mine is a full size SUV weighted around 5000 lbs
- 2) The car behind me is a full size sedan weighted 3550 lbs
- 3) My car is a small compact car weighted 2530 lbs
- 4) When a small compact car is sandwiched and smashed from behind between two big cars, the smallest car definitely suffers the most severe damage.
- 5) According to the laws of physics, the larger sedan behind me hit my compact's rear-end bumper to bumper at some speed; this causes my compact car to move forward at a higher speed. (You need to have some basic understanding of Physics to know this point.)
- 6) The severe damage as seen on my car's front-end is a result of my compact being pushed forward at a higher speed and squeezed under the big SUV's rear bumper. My small car's front bumper was too low to reach the rear bumper of the big SUV. That is why my small car suffered a severe front-end damage. I have photos of my damaged small car with the front bumper still mostly straight. It does not make sense to use my front-end damage to prove that I was at fault as my car was pushed forward to hit that SUV's rear bumper.

4) Mr. Gonzalez treated me unfairly with bias

Here is the list of cars shown in the police report: V1 V4 V3(my car) V2

- 1) According to the order in the queue, I should be either the 3rd or 2nd one to be interviewed, but I was the last one. The fact that Officer Gonzalez decided to interview all other white male drivers before me shows that he had a pre-existing bias in his mind even before taking our statements, else he should have conducted the interviews in a nature and fair order.
- 2) Officer Gonzalez informed me at the scene that the driver behind me admitted to hitting my car. Officer Gonzalez also told me the driver had stated I hit the SUV in front of me first before he hit me, which is not true. I told Officer Gonzalez that driver was trying to get away from his own fault by blaming the victim -- me. Officer Gonzalez completely ignored the key portions of my statement that I was at a complete stop and that the car behind me hit mine from behind. He is selective to believe what he personally wanted to believe and played favoritism, instead of rightfully played his role as a police officer to give a fair and honest report.
- 3) The driver who hit me from behind caused all the damages was let go without receiving a ticket. I wonder if any police would let me go without receiving a careless driving ticket if I hit someone else from behind? How is this justified in the state of New Jersey?



I received confirmation from the Greenbrook police station that there are cameras in the area of the accident. Per Greenbrook Policeman, the tape is stored with the State Government. Since I am suing Mr. Gonzalez, I would like to request the court to subpoena the camera recording. Once we have the recording, the truth will speak for itself.

I feel deeply sad and greatly frustrated to see that a person of authority such as Officer Gonzalez failing to conduct a proper, unbiased accident investigation and unable to produce an accurate and objective police report, which the minimum the citizenry should expect from a police officer sworn to uphold the law.

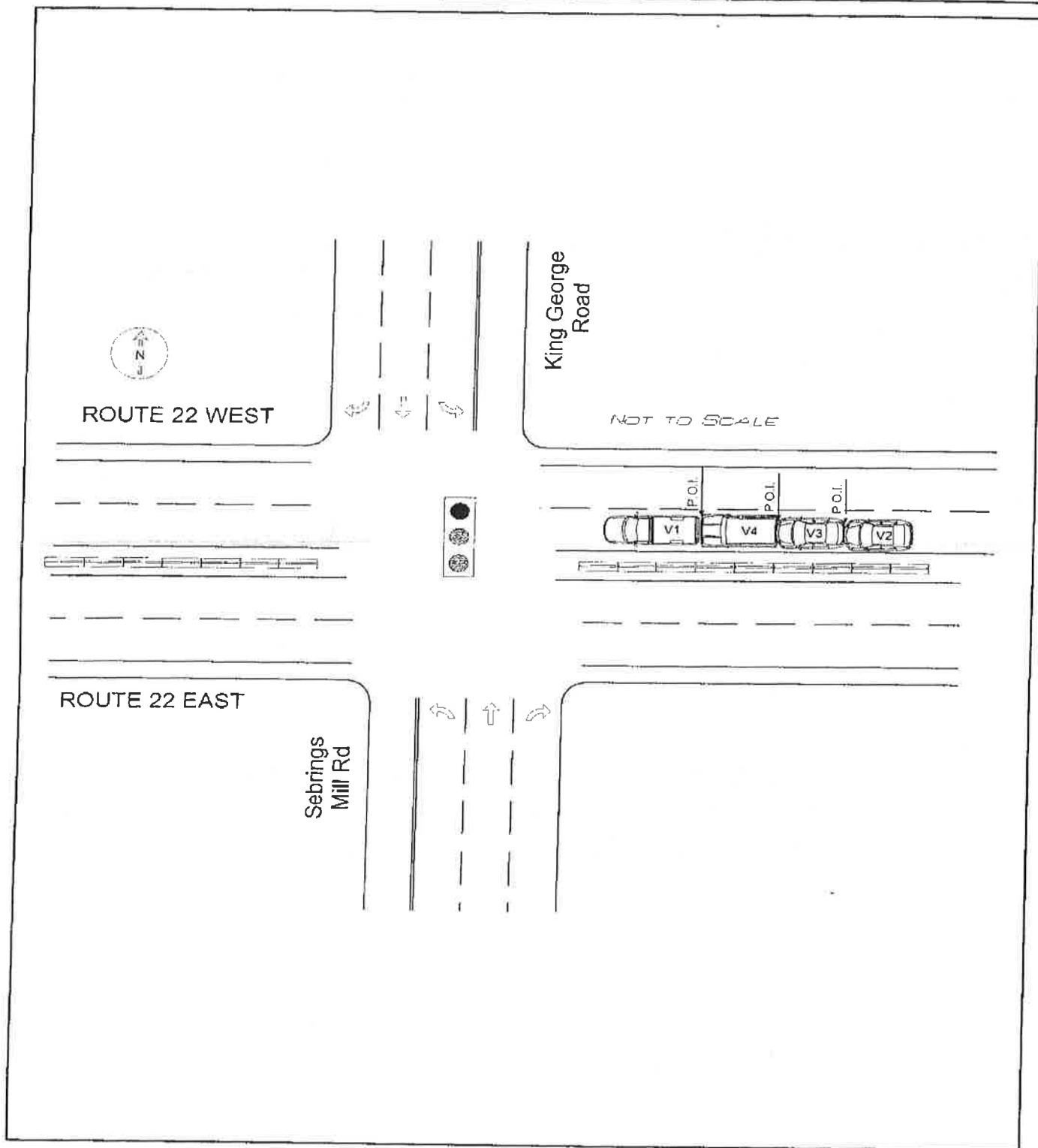
