Federico Bado was wrongfully arrested for the charge of Conspiracy to Distribute Cocaine 3rd Degree, Possession of Cocaine 3rd Degree, Possession With Intent to Distribute Cocaine 3rd Degree and Distribution of Cocaine 3rd Degree, incarcerated in the Morris County Correctional Facility and county lock up without bail until 9:00 p.m. The investigating officers were or should have been aware that Mr. Bado was not a person of interest. There was no probable cause for the Morristown Police Department to have arrested Mr. Bado or for the entities and individuals identified in the addendum to have recommended or otherwise participated in the claimant's arrest. The charges against the claimant were dismissed on July 11, 2019.
