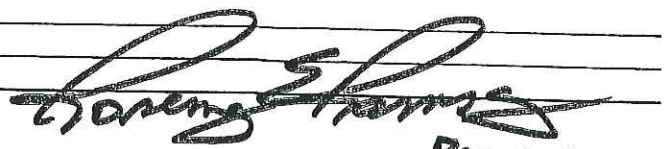

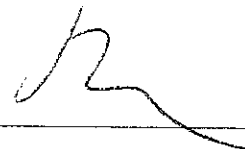

These issues, of Malicious Prosecution, Defamation of Character, Wrongful Imprisonment, and False Arrests let alone Abuse either it be Sexual Abuse or Physical Abuse all came from Mrs. Blanche Laura Harty. There have been numerous experiences I've Had with Mrs. Blanche Laura Harty either it be her forcing sex onto me in the beginning of our relationship too prior to the divorce. For example, I waited two years too have sexual relations with Mrs. Blanche Laura Harty, but in 1998 when we first started dating I was standing outside on the patio at 30 Cherokee Ave Rockaway NJ. Blanche Harty came outside from being in the house and told me quote "That its time to have SEX": end quote my statement too she was that I am not READY!! Except she forced me inside by pulling me into the house and into the bedroom. She proceeds too unzip my pants and starts touching me for me to get aroused. She proceeds too perform oral sex onto me. I was NOT READY!!! Too have intercourse with her, I considered her a Friend. But she wanted more of me than what I wanted to give. After that the only way I could have any type of intercourse with her was with other stimulus. The Sex, our love making sessions were always Forced by her let alone we had to use other stimulus to fulfill my obligation to her as a Man as a boyfriend as a husband. I got so fed up with dealing with her forceful ways. I told her "I was not Sexually Attracted too her" based on her violent, abusive, controlling personality.

The marriage was not loving, was not compassionate, and was not romantic let alone sensitive or respectful of one's thought and ideas. Everything had to be her way and only her way, including where we lived especially three houses down from her mother and father. Since she grew up in Whippany she has friends on the Hanover Township Police Department let alone friends within the town. This relationship was based on Force was based on Abuse, Violence, Control, Manipulation of me, of our business Hario Wholesale Lighting Inc., which I made her 51% owner of. Another mistake I made. The "Retaliation" onto me for telling her I am not sexually attracted to her is overwhelming, I was being truthful with her. But she gets her Mother and Father involved in this rather than coming too me and discussing these issues. That day her parents call me on the phone when I was walking with Jason when he was only 1 year old, they ask me too come to the house they have something to tell me. I walk into the house and they (Blanches Mother Blanca Lopez and Blanches Father Alberlardo Lopez) proceeds to scream and yell at me. Their yelling while Jason is in the Middle of this, telling me I should kiss the ground that Blanche walks on without her I would not have the House, the Car, the Money let alone the business. They precede too verbally abuse me while Jason was in the middle of all this, when her Father started cursing at me I said I'm DONE!!! With this I proceed to pick up Jason and walk out. I turn too Blanche and I ask, are you coming? She tells me NO! I am staying with my Parents!!! I walk out of the house and her Mother Blanca Lopez comes up to me and tells me Do Not Get a Divorce. I take Jason home, feed him, change him do my fatherly duties let alone parent duties. She comes into the house and starts screaming at me yelling - Why did you say that to me? She misunderstood my statement too her. I tried to explain why I said it, I told her I want to make love too her out of Compassion. Romance, Sensitivity **Not** FORCE. I know I hurt her by telling her I am not sexually attracted to her, I did not mean to hurt her ego or her as a person, I just wanted to make love too her the real way the Romantic, Compassionate way. But Blanche Retaliated onto me for another reason and the biggest reason is I became Mr. MOM too Jason the nurturer, the caregiver, the emotional provider too our SON.

By growing a successful lighting business surrounding myself with ethical, moral, powerful business owners either threw New Jersey Association Women Business Owners, Morris County Chamber of

Commerce, BNI, Litip, Women's Leadership Exchange I developed a successful business. Except the fact is on December 18th 2006 I reported the violence too Hanover Township Police Department. Officer Williams faxes the report I made too DYFS and Morris County Prosecutors Office but on June 18th 2007 Blanche Laura Harty tried covering up her abusive, violent, uncompassionate, insensitive personality. By throwing me into an environment where I should not have been thrown into either jail or a situation such as homelessness, financial ruin, let alone away from my son. Since Blanche is the abuser I am concerned about Jason's Safety, he even has a mark on his left side of his nose. Which Blanche claims he pulled on a cord that is attached to an iron, I feel she squeezed his left side of his nose leaving a welt. It was not a huge welt but it still hurt him.

In addition to when I wanted to get involved in the Katrina Relief Efforts with Kindercare Learning Center of Whippany Mrs. Gina McGovern, I had everything planned out. From the drop off location too how I am going to get there. Penske Trucking gave me a truck for \$100.00 for a five day excursion. I spoke with New Orleans Police Department, National Guard and State Police to get a drop off location except I did not tell Blanche about my idea; I am sure Gina told her and just played it out. But that day Blanche went over the line by Verbally Abusing me, telling me I'm Not a real Man, Cursing at me let alone pulling me out of the bedroom telling me to get the F out. All the abuse came from her not me. She covered it up by throwing me into jai, by making false allegations of domestic violence, by lying too the prosecutor's office, the judges, the officers of Hanover Township Police.

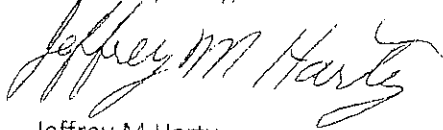
