Mr. Chen at this time was conscious and speaking with me while we waited for EMS. Mr. Chen at this time does not remember what happened.

Minutes later EMS 7 arrived on scene and quickly aided Mr. Chen and transported him to JCMC. EMS 7 at this time could not wait for ALS. After further investigation, Luis Arredondo-Padilla

At this time, Mr. Arredondo-Padilla stated he was quick enough to close the door but Mr. Chen trying to avoid hitting his car door swerved and pressed on the break causing him to fly off his bike. Please note, I observed no damages to the vehicle and did noticed the bike's skid marked on the black top. Also, the camera on 11th and Summit Ave is currently not working.
