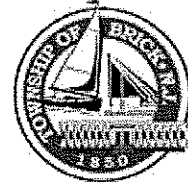

On 01/08/2021 at approximately 1815 hours Ptl. Gordon #297 and I (Ptl. McCaffery #298) responded to the wooded area East of 570 Route 70 (Target) in reference to a welfare check. Dispatch advised that the caller, Samantha Mazur, stated she has not heard from her parents, Adam and Kathleen Winit, since 12/25/2020 and was concerned. Dispatch further advised that the caller stated her parents are homeless and they are known to live in a tent in that area but she was unsure of their exact location.

Ptl. Gordon and I checked the wooded area East of Target. Approximately 200 feet into the woods we spoke with a resident who has set up camp in that area. He advised that he has not seen the Winit's since around Christmas time. While checking the area, I spoke with Samantha on the phone who stated she has not kept in contact with her parents in the last few years but her sister, Allison Blaine does. It was Allison who told her she hasn't heard from them since 12/25/2020 which caused Samantha to contact police. Samantha also added that Allison is a known offender and might not be cooperative with police.

After speaking with Samantha I contacted Allison. Allison stated she has not spoke to her parents since 12/25/2020 and was not sure exactly where her parents set up their camp. Allison believed it was the woods directly behind Target but stated they could possibly be in Lakewood. Allison explained that she stays in contact with her parents and they are habitual heroin users. Allison also added that her parents are known to travel around. Should be noted Allison would not give police her information.

After speaking with Allison and Samantha, we checked the wooded area further West on Cederbridge Ave .on the Eastbound side. We spoke with residents in the area who stated since the construction started, he believes the Winit's traveled to Lakewood. While checking the wooded area for the Winit's, Allison contacted my cell. Allison stated that she was Facebook Messaging her parent's Minister, Minister Steve, at the moment. Allison explained he messaged her stating he saw them two days ago in Lakewood and gave them propane tanks for heat in their tents.

Allison further stated that Minister Steve messaged her stating her parents were okay and that they do not want to be bothered by Police or their daughters. Screen shots of the conversation are attached to the report. Allison was advised to contact Lakewood PD if she wished to have them follow up and locate her parents. Allison was also advised to contact her nearest police department if she wished to report them missing. I contacted Samantha and advised her of what her sister stated and that a report will be completed.

No further police action was taken, BWC available.
