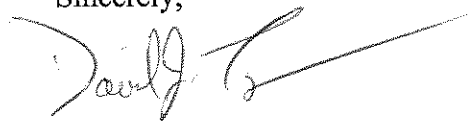

Good evening, while I recognize that the assembly approved Assembly Bill No. A3902, which provided for municipalities to defer tax payments to school districts, I have spoken to the Executive Director of the Senate Majority Office and confirmed with Senate leadership that A3902 will not move forward in its current form in the Senate.

We are entertaining maybe the interest piece or other pieces that can be postponed, but not the amount of the property tax bill which goes to school districts. As always, I welcome any feedback.
