

AN ORDINANCE AMENDING CHAPTER 2, ADMINISTRATION, SECTION
2-18.1(a), POLICE DEPARTMENT, OF THE
REVISED GENERAL ORDINANCES OF THE
TOWNSHIP OF SPARTA

WHEREAS, the Township Council of the Township of Sparta wishes to amend the organizational structure of its Police Department to provide for a maximum of ONE (1) Captain, three (3) lieutenants and a maximum of six (6) sergeants,

WHEREAS, the Township Council of the Township of Sparta has determined that § 2-18 1 of the Code of the Township of Sparta requires amendment to provide for the maximum allowable number of officers and patrolmen in its Police Department, to be consistent with the underlying statute, N.J.S.A. § 40A.14-118, and Reuter v. The Borough Council of The Borough of Fort Lee, 167 N.J. 38 (2001),

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Township Council of the Township of Sparta, County of Sussex, State of New Jersey, as follows

Section 1 Section 2-18 1(a) of the Code of the Township of Sparta is hereby deleted in its entirety

Section 2 Section 2-18 1(a) of the Code of the Township of Sparta shall hereby read as follows

There is hereby created a Department of Police also known as the Police Department. The Police Department shall consist of the following positions, in order of their rank within the department, and such other employees as the Manager shall from time to time deem necessary and proper

- 1 One (1) Chief of Police,
2. One (1) Captain,
- 3 No more than three (3) lieutenants,
- 4 No more than six (6) Sergeants, and
- 5 No more than forty (40) patrolmen or patrolwomen.
- 6 The authorized number of officers in the above ranks may be increased and/or exceeded to permit the Appointing Authority in his discretion to permanently appoint an officer to replace any other officer no longer on active service on terminal leave pending resignation or retirement; provided, however that said resigning/reiring officer has provided written notice of the resignation/retirement and its effective date, and same has been accepted by the Appointing Authority

Severability. If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

Repealer. All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety

Effective date. This Ordinance shall take effect after its final passage and publication as required by law
