1. I am requesting all certified payrolls for all companies working on the Hooper Ave Elementary, Intermediate East, and Cedar Grove Elementary since January 1, 2021.
2. I write to request access to and a copy of a listing of all Toms River Regional School District's employees first and last names, email address, title/position, and primary department. Please provide this information in an electronic format such as Excel or csv format to this email address is possible.
3. Provide copies of all contract/lease agreements for the use of the RWJ Barnabas Health Arena. Provide copies of all proposed contract/lease agreements for the use of the RWJ Barnabas Health Arena by any and all entities between January 1, 2022 and June 30, 2022. Provide copies of any and all minutes of meetings, documents, memoranda, summaries and/or correspondence regarding the use of the arena by the Ocean County Health Department or any other entity for the purpose of administering Covid vaccines between January 2021 and December 31, 2021. Provide contact information (names, addresses, telephone numbers, facsimile numbers and email addresses) for all parties/entities who are legally bound by the contracts/leases for the use of the arena for the purpose of administering Covid vaccines between January 2021 and December 31, 2021 and who will be legally bound by the proposed contracts/leases for the use of the arena for the purpose of administering Covid vaccines during 2022. Provide copies of minutes of meeting, documents, memoranda, summaries and/or correspondence that were generated by or received by the TRRS in support of or against the use of the arena for the purpose of administering Covid vaccines. Provide copies of contracts and contact information (names, addresses, telephone numbers, facsimile numbers and email addresses) for the following: individuals, contractors, subcontractors, vendors, lessees who/which oversaw or will oversee the general operation of the arena, including those who are/have been/will be responsible for the following: security, maintenance, assembling/disassembling of equipment, and providing supplies and/or services to facilitate the use of the arena for the purpose of administering Covid vaccinations between January 1, 2021 and December 31, 2021 and January 1, 2022 and June 30, 2022. Provide copies of all documents, memoranda, summaries and/or correspondence relating to the dates and hours of operation during which Covid vaccinations were administered at the arena during 2021 and the proposed dates and hours of operation during which Covid vaccines will be administered between January 1, 2022 and June 30, 2022. Provide copies of all documents, memoranda, summaries and/or correspondence relative to the dates and times during which Covid vaccinations were scheduled to be administered at the arena but were temporarily ceased during 2021, or are expected to be temporarily ceased between January 1, 2022 and June 30, 2022. Provide copies of all documents, memoranda, summaries and/or correspondence relative to the reasons/protocol for ceasing or temporarily ceasing the administering of Covid vaccines in 2021, and the proposed cessations, if any, for the period between January 1, 2022 and June 30, 2022, and the contact information (names, addresses, telephone numbers, facsimile numbers, and email addresses) for the entity/individuals responsible for the decision to cease or temporarily cease the administering of vaccines. Provide data reflecting the monthly total of Covid vaccines

administered during the 2021 at the arena.

4. All contract/lease agreements for the use of the RWJ Barnabas Health Arena located at TRHSN by any and all entities during 2021 and January 1, 2022 - June 30, 2022.

5. Any/All vendor payee payments for the year 2021 to include vendor name, address, city/state/zip code, check date, check number, check amount, department agency, type of payment (contract, grant, etc.) and description of services or purpose of payment.

6. Report by Colliers Engineering on the issues with the façade at TR Intermediate South that was submitted to the school district sometime during 2021.

7. Copies of records from the construction of TR Intermediate South seeking letter awarding the contract for the construction, the records showing how much was paid for the construction, inspection records on the work that was done. In addition, I would like copies of reports about the water leaks associated with the roof and/or facade. I am trying to find out when the first leaks were reported, how frequently they happened, and how severe they were.
