On the above date and time, I, Ptl. Jimenez, was conducting uniformed bike patrol on the south end of the boardwalk near Beachcomber. At that time I observed a male later identified as Joshua R. Massei (DOB: [REDACTED] 984) vaping on the boardwalk. My partner, Ptl. Raasch, and I approached Massei and informed him that it was prohibited to vape on the boardwalk and he needed to step down to the street end of Lincoln Avenue and Ocean Terrace with us so we could gather his information.

Massei became irate and refused to step off the boardwalk. He started to yell and create a disturbance where the public peace was broken. Eventually he reluctantly came to the street end of Lincoln Avenue and Ocean Terrace, however, he continued to be aggressive by yelling and creating disturbance even after being told multiple times to calm down and lower his voice. Massei additionally tried to get myself and Ptl. Raasch into a physical altercation by moving towards us aggressively and telling us to strike him.

At that time other officers arrived on scene and attempted to place Massei under arrest. He physically resisted attempts to place him in handcuffs before he was taken to the ground, handcuffed, and transported back to headquarters to be booked.

On the above date and time, I PTL. Zilenas was conducting a routine patrol of Seaside Heights Using my marked patrol vehicle #25. While on patrol, I was dispatched to assist a code enforcement officer with a suspicious person. Shortly after, I received another report via my two-way radio to respond to the location urgently. When I arrived, I observed a highly irate male, later identified as Mr. Joshu R Massei, screaming and yelling curse words in public, causing a disturbance with the public view present.

Mr. Massei was also in a fighting stance, moving toward code enforcement officers. At this point, I made contact with the male and advised him that he was being placed under arrest for disorderly conduct (2C:33-2A(1)). I attempted to put handcuffs on Mr. Massei, and I was able to set one cuff on him. However, at that point, he became irate, resisted my control, moved his right arm in an upward motion, and attempted to push officers away in an effort to avoid being arrested. Multiple officers tried to retrieve his right arm but were unable to successfully secure the handcuffs on him.

After Mr. Massei displayed aggressive behavior, I used a takedown technique to bring him under control to effectuate the arrest. Despite this, he continued to resist our attempts to restrain him. After several unsuccessful tries, I managed to grab his right arm and place it behind his back, allowing us to apply handcuffs. Shortly afterward, additional officers arrived on the scene.

Myself and Ptl. DiGiovanni escorted Mr. Massei to a marked patrol vehicle, where he continued to resist police control. Mr. Massei was then placed on the side of the patrol vehicle, where officers could perform a search incident to arrest. After the search incident to arrest yielded no results, officers placed Mr. Massei, who was still resisting police control, into the marked patrol vehicle. Next, he was transported to 116 Sherman Avenue for booking and processing. During the booking process, Mr. Massei was offered medical attention, and Tri-Boro EMS came to evaluate the patient.

Mr. Massei later refused medical attention. It is worth noting that he was uncooperative throughout the entire process until he was released. Later that night, Mr. Massei was released on a summons. He handed officers his copy of the summons and left on his own recognizance.
