SEASIDE HEIGHTS POLICE DEPARTMENT

PTL. ADAM GREENGROVE

ON THE LIST DATE AND TIME, I PTL. ADAM GREENGROVE, RESPONDED TO LINCOLN AVENUE AND BOARDWALK FOR A LARGE FIGHT IN WHICH PTL. GISINGER WAS OUT MANNED AND REQUESTED BACK UP. UPON MY ARRIVAL I OBSERVED SEVERAL PEOPLE ENGAGED IN FISTICUFFS. SHERIFFS OFFICER TRUST AT THIS POINT HAD BEGAN BREAKING IT UP AND HAD A FEMALE, BRITTANY PAYNE-BARIEYCA, ON THE GROUND WHO WAS ACTIVELY RESISTING HIS CONTROL. S/O TRUST TRIED SEVERAL TIMES TO CALM HER DOWN BUT TO NO AVAIL. I THEN ISSUED A SHORT BURST OF MY DEPARTMENTAL OC TO HER FACE TO CEASE THIS BEHAVIOR. S/O TRUST AND PTL. ROSS WERE ABLE TO ESCORT HER OFF THE BOARDWALK.

I THEN DIRECTED MY ATTENTION TO ALEXIS HOLLOWAY WHO WAS CAUSING A DISTURBANCE AND WAS YELLING AT OTHER PATRONS. I THEN SECURED HER IN HANDCUFFS AND PLACED HER UNDER ARREST FOR DISORDERLY CONDUCT. AT THIS TIME SEVERAL OTHER OFFICERS HAD MADE ARRESTS FOR THIS INCIDENT AND WERE ALL AWAITING TRANSPORT. DURING THIS TIME, PAYNE-BARIEYCA HAD KICKED PTL. GRZELAK IN THE FACE DURING AN OUTBURST. ONCE THE TRANSPORT VAN ARRIVED SHE AGAIN WOULD NOT CALM DOWN AND HAD TO BE CARRIED TO THE VAN DURING THIS TIME SHE SPIT ON PTL. ROSS IN THE FACE.

PAYNE-BARIEYCA WAS TRANSPORTED TO SEASIDE HEIGHTS POLICE DEPARTMENT AND ATTEMPTS TO DECON HER FROM THE OC SPRAY WERE UNSUCCESSFUL DUE TO HER BEING IRATE AND COMBATIVE. SHE WAS ADVISED OF HER CHARGES AND THAT SHE NEEDED TO BE FINGERPRINTED SHE THEN STATED SHE WILL NOT BE FINGERPRINTED. A COMPLAINT-WARRANT WAS THEN GENERATED AND SHE WAS LATER LODGED AT OCEAN COUNTY JAIL.

HOLLOWAY WAS CHARGED WITH DISORDERLY CONDUCT AND WAS RELEASED FROM CUSTODY PENDING A COURT DATE.

A USE OF FORCE WAS COMPLETED FOR THIS INCIDENT.

Gisinger called for backup in regards to a large fight on the boardwalk in the area of Lincoln Avenue and Ocean Terrace. I responded to the situation and observed Sheriff's Officer Trust and PTL. Greengrove attempting to control a female, Brittney Payne-Bariexca, who was actively resisting control. I assisted in physically controlling Payne-Bariexca and bringing her to the ground. One of the female individuals involved was actively assaulting Mr. Sternberg as I was attempting to separate him from the rest of the group. After bringing Mr. Sternberg far enough away from the rest of the group I was able to calm him down and place him in handcuffs. I then escorted Mr. Sternberg to the corner of Hamilton Avenue and Ocean Terrace where he was transported to Seaside Heights Police Department. Refer to PTL. He advised me he was involved in the fight along with bystanders. I then placed the male under arrest for Disorderedly conduct (2C:33-2A(2) . The male was then identified as Walter Maldonado. Mr. Maldonado was transported back to head quarters by myself in marked car #39 to be booked. No further police action was taken.
