The City of Hackensack ("City") records custodian received your Open Public Records Act ("OPRA") Ref. No. 25-171 request on 01-30-25. As such, the seven business day deadline to respond to your request is 02-10-25. This response is therefore being timely submitted in accordance with New Jersey law. See N.J.S.A. 47:1A-5.

RECORDS RESPONSE: All responsive records found with the Building Department, Health Department, and Tax Collector's Office pertaining to a list of properties with liens (all 2024 delinquent taxes have been converted into liens), list of properties with violations from the Building Department and Health Department, and the vacant property list.

The Hackensack Fire Department does not have the capability of generating a report of all properties they have responded to for emergency calls for within the City of Hackensack – the system used only allows for records to be search with a specified address or addresses. If you are able to provide the address or addresses for the properties you would like the fire investigation reports for, the Fire Department would be able to provide any responsive records if found.

Per the Building Department, the property highlighted in green is the only property that has registered at the time of sending this response. The others on the list have been notified with no response.
