Incident Report



Today is Tuesday February 25th, 2025 and I, PO Alexander Miller #88, am working the 1600-0000 hours tour of duty assigned to Emergency Response Unit in the South District in Radio Car #110. I am under the direct supervision of Sgt. Jason Falco and Command of Lt. E. Sellick.

At approximately 22:55 hours, while on roving patrol in the area of 4th Street and Bloomfield Street in Hoboken NJ 07030, I observed a vehicle facing eastbound on the south side of 4th Street. It should be noted that 4th Street is a one way street traveling westbound. I parked radio car #110 near the intersection of Bloomfield Street and 4th Street and approached the white Landrover bearing New Jersey Registration U83URT. I approached the driver side window and observed the driver, Samia Asdi-Alaoui, and her friend having a conversation while beginning the process of unraveling a cigarillo on a tray on Samia's lap. I asked for a valid drivers license, registration, and insurance which was provided to me. Lt. Sellick, Sgt. R. Miller, PO K. Del La Cruz, PO Archilla, and PO Chen arrived on scene.

As I provided the drivers license information to dispatch via radio communications to check for validity, Sgt. Miller and PO Archilla spoke with Samia. They asked her how the car came to be in it's current position, to which she responded she was following the GPS. When asked which application she used, she stated Google Maps. While conversing, Sgt. Miller could observe bloodshot watery eyes as well as slow speech. Samia was asked to turn the vehicle off, which she replied that it was already off. The vehicle was in fact on and the engine could be heard. Samia was asked to step out of the car and asked what she had done tonight. She stated she went to East LA, located at 508 Washington Street, Hoboken NJ for the Taco Special, which included a margarita. Due to Samia's condition and her statement of her consuming alcoholic beverages, PO Archilla conducted a Stand Field Sobriety Test. See PO Archilla's supplemental report for further information.

Based on PO Archilla's on scene observations during the Standard Field Sobriety Test (SFST), Samia was placed under arrest for driving under the influence. PO A. Rivera arrived on scene to conduct a search incident to the arrest with negative results for contraband. Samia was placed in the rear of radio car #128 and transported to the Hoboken Police Department, checking the rear seat prior to and after transport which yielded negative results for contraband. Samia was placed in secure hold in the Alco Test room.

Samia refused to give a breath sample for the Alco Test Machine.

**N.J. ATTORNEY GENERAL'S STANDARD STATEMENT
FOR MOTOR VEHICLE OPERATORS (N.J.S.A. 39:4-50.2(e))
(revised & effective July 1 , 2012)**

Enter Defendant's Name Asdi-Alaoui, Samia

The police officer shall read the following:

1. You have been arrested for driving while intoxicated. N.J.S.A. 39:4-50.
2. The law requires you to submit samples of your breath for the purpose of testing to determine alcohol content.
3. A record of the taking of the breath samples, including the test results, will be made. Upon your request, a copy of that record will be made available to you.
4. After you have provided samples of your breath for testing, you have the right, at your own expense, to have a person or physician of your own selection take independent samples of your breath, blood or urine for independent testing.
5. If you refuse to provide samples of your breath, you will be issued a separate summons for the refusal. A court may find you guilty of both refusal and driving while intoxicated.
6. If a court finds you guilty of the refusal, you will be subject to various penalties, including license revocation of up to 20 years, a fine of up to \$2000, installation of an ignition interlock, and referral to an Intoxicated Driver Resource Center. These penalties may be in addition to penalties imposed by the court for any other offense of which you are found guilty.
7. You have no legal right to have an attorney, physician or anyone else present for the purpose of taking the breath samples. You have no legal right to refuse to give, or delay giving, samples of your breath.
8. Any response from you that is ambiguous or conditional, in any respect, to my request that you provide breath samples, will be treated as a refusal to submit to breath testing. Even if you agree to take the test, but then do not follow my instructions, do not properly perform the test, or do not provide sufficient breath samples, I will charge you with refusal to submit to breath testing.
9. I repeat, the law requires you to submit samples of your breath for testing. Will you submit the samples of your breath?

Answer I want my lawyer

If the arrested person does not respond, or gives any ambiguous or conditional answer short of an unequivocal "yes," the police officer shall read the following.

Your answer is not acceptable. The law requires that you submit samples of your breath for breath testing. If you do not answer, or answer with anything other than "yes," I will charge you with refusal. Now, I ask you again, will you submit to breath testing?
