AN INVESTIGATION REGARDING STOLEN GARBAGE CANS. UPON MY ARRIVAL, I MADE CONTACT WITH THE CALLER/COMPLAINANT, MS. SHARON HOYT.

MS. HOYT DISCLOSED THAT THE PROPERTY IS OWNED BY HER MOTHER, MRS. KAREN SERELIS. THEY ARE THE LANDLORDS FOR THE PROPERTY AND ARE HAVING RECURRENT ISSUES WITH THE FIRST FLOOR TENANTS, ALICE LUNA AND CHRISTINA LUNA. MS. HOYT STATED THAT YESTERDAY A BLACK GARBAGE CAN PURCHASED FROM HOME DEPOT WITH A BLACK LID AND NO WHEELS VALUED AT \$35 WAS STOLEN. SHE REPLACED THE GARBAGE CAN WITH A BLACK GARBAGE CAN FROM LOWES WITH A BLACK LID AND WHEELS VALUED AT \$55. ON THIS DATE THE GARBAGE CAN WAS ALSO ALLEGEDLY STOLEN.

MS. HOYT DID NOT WITNESS THE THEFT, NOR DID ANY OTHER PARTY. THERE ARE NO EXTERIOR SURVEILLANCE CAMERAS REPORTED ON THE PROPERTY. MS. HOYT STATED THAT IN THE PAST SHE SAW THE FIRST FLOOR TENANTS HOSING OFF AND CLEANING A GARBAGE CAN ON THE REAR PATIO AND SO SHE BELIEVES THEY STOLE THESE GARBAGE CANS. SHE BELIEVES THE MOTIVE IS TO STEAL THE GARBAGE CANS PURCHASED BY THE LANDLORD BUT USED BY THE SECOND FLOOR TENANTS IN AN EFFORT TO DRIVE THEM OUT OF THE PROPERTY OUT OF FRUSTRATION SO THEY HAVE THE PROPERTY TO THEMSELVES. MS. HOYT STATED THEY ARE "SECTION EIGHT" AND "HOARDERS".

MS. HOYT COMPLETED AND SIGNED A PROPERTY DISCLAIMER FORM. THE TOTAL VALUE OF BOTH GARBAGE CANS TOTALS \$90 USC. SHE WAS PROVIDED WITH THE CASE NUMBER AND ADVISED TO CONTACT THIS AGENCY SHOULD THIS ISSUE PERSIST. ALL PRINTOUTS WERE ENCLOSED IN THE CASE FILE.
