The Hackensack Fire Department does not have the capability of generating a report of all properties within the City of Hackensack with fire damage – the system used only allows for records to be search with a specified address or addresses. If you are able to provide the address or addresses for the properties you would like the fire reports for, the Fire Department would be able to provide any responsive records if found.
