I'm writing to report a bright exterior light from Giant Farmer's Market across the street from my apartment (appears to be part of their parking lot). The light is extremely intense and beams directly into my apartment windows every evening, often staying on late into the night.

The glare is strong enough that even with my blinds closed, the light still shines through and lights up my living space, you can see it clearly in the attached photos. It's become very disruptive and makes it difficult to relax or sleep comfortably at night.

From what I understand, this may be a violation of Hackensack City Code §175-11, which says lighting fixtures should be arranged so the direct source of light isn't visible from adjacent residential areas and that glare should be eliminated through the use of diffusers or shielding.

I've attached photos showing how the beam shines into my unit and how bright it is inside my apartment. I'm hoping the city can inspect the property and ask the business to redirect, shield, or dim the fixture so it doesn't shine directly into nearby homes.
