On 6/14/2018 at approximately 1800 hours, I was dispatched to 462 Mercer St. for a male urinating in the street. On location, I spoke with the caller, Christopher Dankel, who viewed a white male with arm tattoos, wearing a white tank top, plaid shorts, and a gray hat with red trim. Mr. Dankel said he viewed the male lean against a blue SUV, NJ registration [REDACTED] and urinate along side of it. Mr. Dankel said he was inside his residence during the incident, and two juveniles, [REDACTED] and [REDACTED] also witnessed the suspect. Mr. Dankel, along with another witness, Jacqueline Oehlert approached the male telling him to use a bathroom inside. They said a female that was in the vehicle the suspect was leaning against, had went into 462 Mercer St., and suggested he go in there. The suspect responded by giving them the finger. While calling police, Mr. Dankel said the female returned, and apologized for the male. Mr. Dankel said the police were on the way and the female said she had to go pick up her kid. The suspect then entered the vehicle with her and they left the area. I spoke with Gregory Dick of 462 Mercer St. who said the female driver was his girlfriend, Marissa Tompkins, and that he did not know the suspect, only that he was a friend of one of his girlfriend's friends. He called Ms. Tompkins who stated she only knew the male as Jordan Beaver, and that he lives in Palmyra. She last saw him on Crescent Blvd. in Collingswood, where she let him out after striking her in the head. She was advised to contact Collingswood Police to pursue the matter.
