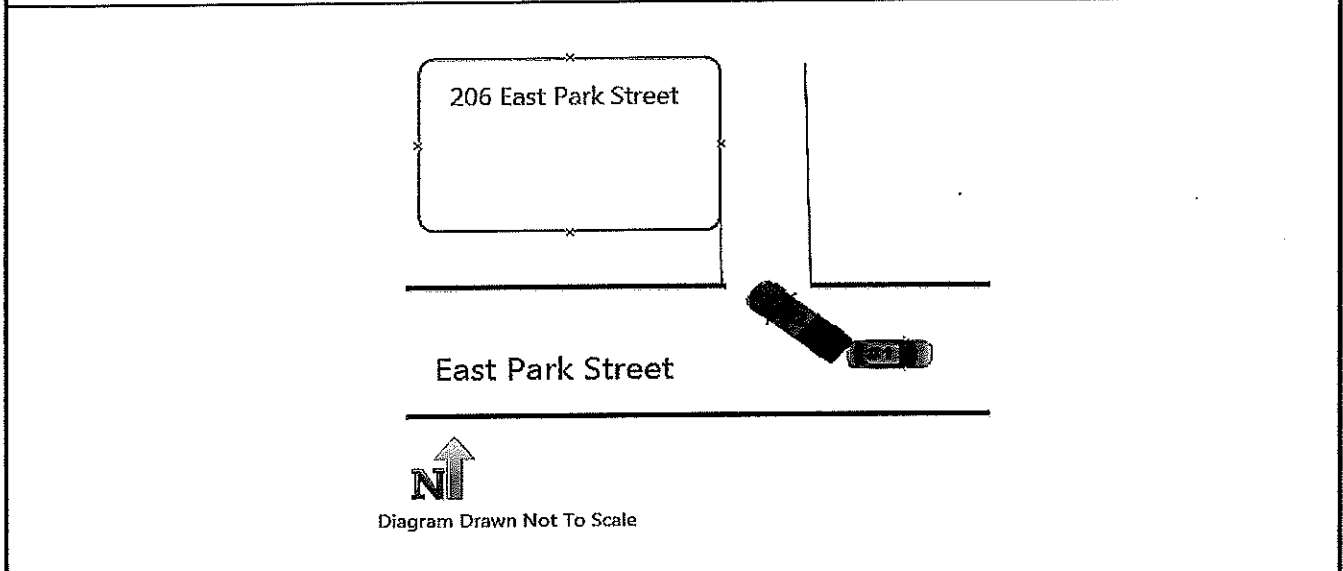

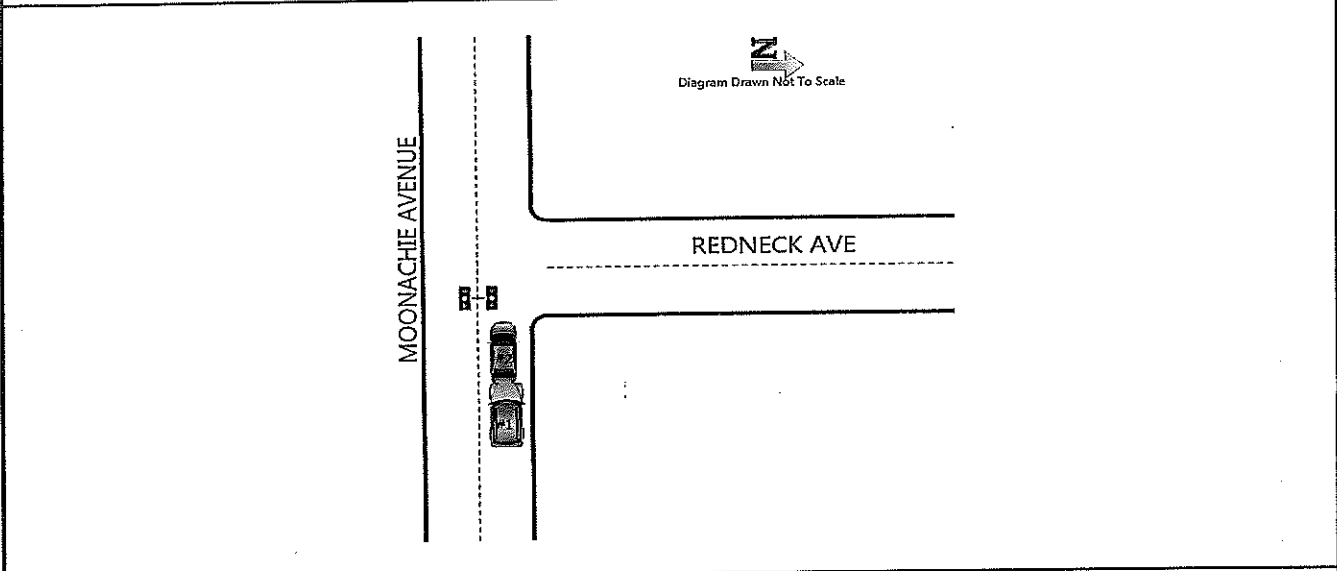

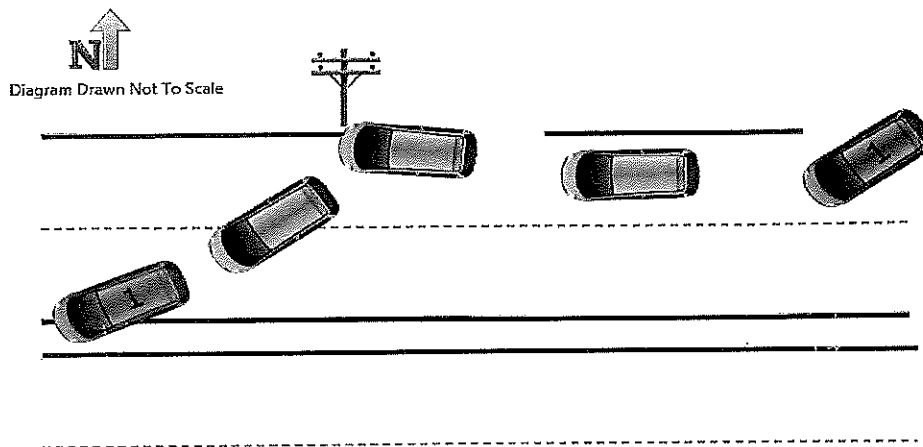

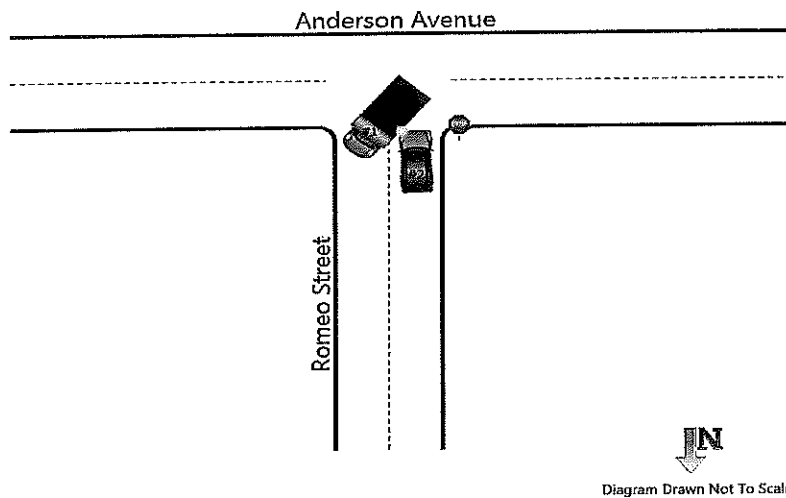

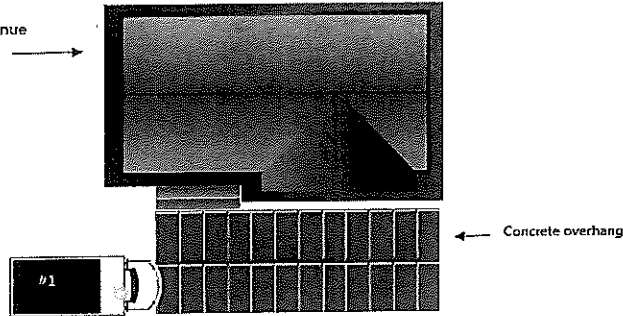

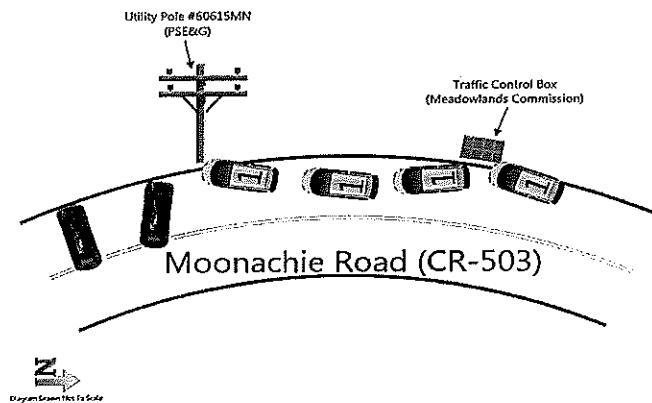

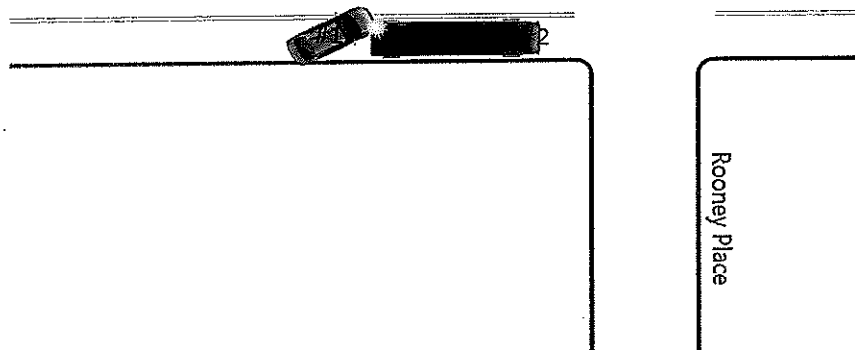

145 Crash Description/Narrative

Vehicle #1 was traveling south on Moonachie Road behind Vehicle #2, which was stopped. Vehicle #1 then began passing Vehicle #2, making contact in the process and striking Vehicle #2. Vehicle #2 was stopped parallel to the sidewalk upon my arrival.

The operator of Vehicle #1 stated that Vehicle #2 was stopped on the side of the road and not moving. She then began to pass the stopped bus when the bus began pulling away from the curb line, reentering the roadway abruptly and not allowing Vehicle #1 to stop in time to avoid the crash.

The operator of Vehicle #2 stated that he was stopped along the curb line with the door open to allow passengers to enter and exit the bus. He then felt an impact when Vehicle #1 struck the parked bus while attempting to pass it.

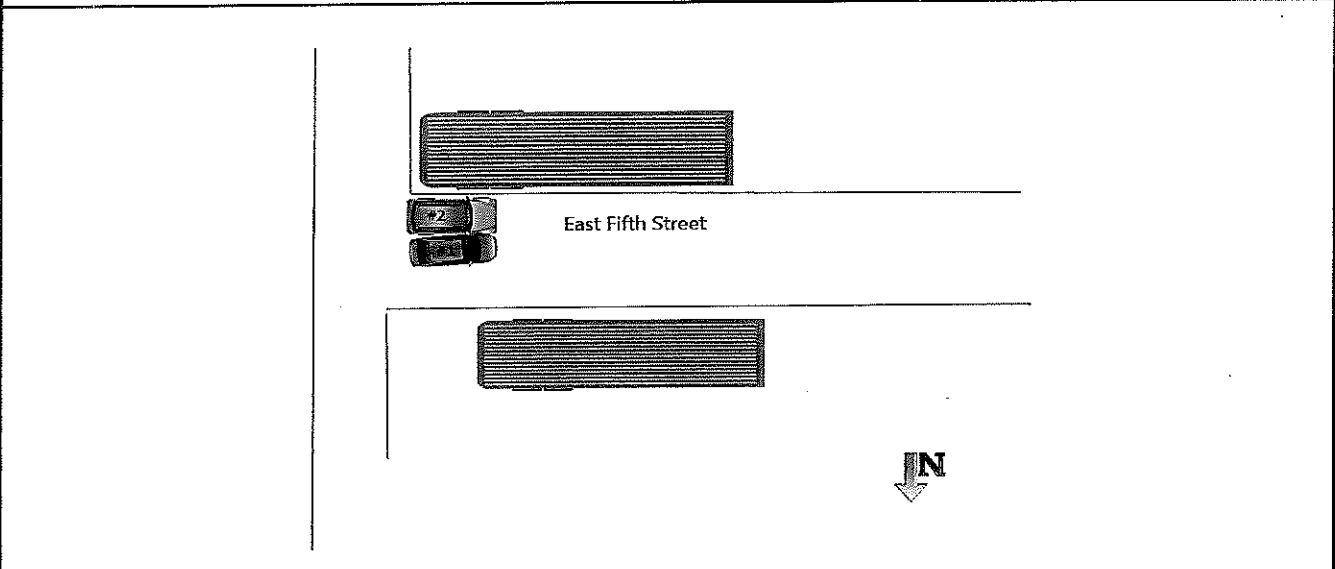
