Narrative

On Saturday September 28 2019, Mark Peteya, boyfriend to Evelyn Xochicali, came in to Police Headquarters to report additional information about his girlfriends stolen dog. Mark stated that a neighbor that lives at 1514 Malibu Drive looked over their surveillance footage from the day the dog was taken and did not see the suspect vehicle described, but saw something else that was suspicious.

Mark said the neighbor stated that a Public Works garbage truck circled the block a few times and was also parked nearby the victim's house approximately 10 to 15 minutes before the dog was taken. Mark said that the neighbor found this suspicious because the sanitation workers come at 8 am and not so late in the afternoon. Mark said there could be a possibility the driver of the garbage truck was watching the house and the puppy.

Mark did not have the neighbor's information, or the surveillance footage, but said the neighbor is working on getting him a copy of the footage. I advised Mark when he gets this footage he can bring it to Police Headquarters so it can be submitted as evidence.
