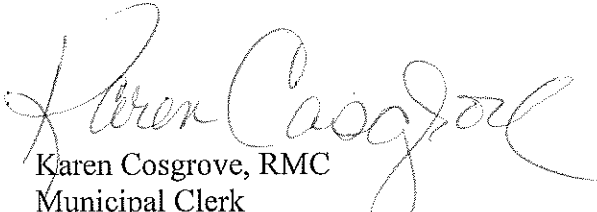

All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
