Narrative

I was on Patrol in the area of Rt. 130 S and North Park Drive when I observed a white Van bearing PA KPW8582, occupying the center lane operating without its front headlights or rear tail lamps on. The vehicle also failed to maintain its lane, swerving from side to side. At this point I conducted a motor vehicle stop at 7500 Rt. 130 S, identifying the driver as Johnnie Lloyd Jr. As I approached the driver side open window, I advised Johnnie the reason for the stop in which he stated he did not realize he was swerving and did not have his vehicles lights on. While speaking with Johnnie I noticed when I asked for his valid documents numerous times he only produced his license. Also while speaking with Johnnie I observed his words and movement to be slow. He also avoided any eye contact with me. When Johnnie finally made eye contact with me I noticed his eyes to be moving in an uncontrolled manner. When asked if he had any alcoholic drinks he did not answer the question but stated he just left work. I did not detect any odor of an alcoholic beverage or chemical coming from Johnnie. Based upon my observations, I requested Traffic Officer Mireles to respond to my location for a possible impaired driver. See Ptl. Mireles Master Incident Report for further information. Flanagan's responded to my location and removed the vehicle from the roadway without further incident.

Narrative

On January 12, 2018 I responded to 7500 Route 130 (Supremo Food Markey) to assist Ofc. Martinez #223 on a motor vehicle stop with a possible intoxicated driver. Upon arrival, I spoke with Ofc. Martinez and he advised me the driver showed signs of impairment. When I approached the vehicle, I spoke with the driver Johnnie Lloyd, through an open driver side door window. I asked Lloyd if he had consumed any alcoholic beverages and he stated " No". Lloyd then stated " I just smoked a cigar". I asked Lloyd where was he coming from and currently en route to. He stated he was coming from work and was en route to his residence in Camden City. I noticed as Lloyd spoke, his speech was slow and slurred. At times, I had a difficult time understanding the words Lloyd was trying to pronounce. I also noticed Lloyd's eyes were bloodshot red, watery, and his eye lids were droopy. While continuing to converse with Lloyd, he continued to fumble with papers and items in his wallet. I could also detect an odor of a burnt cigar, along with a strong chemical smell coming from the vehicles interior. I asked Lloyd if he had ingested any type of narcotics, he stated again " No, I just smoked a cigar". I then asked Lloyd if he was taking any medications that were prescribed by a physician and he stated " No". I advised Lloyd to exit the vehicle for the purpose of performing some fields sobriety tests and he complied. I asked Lloyd if he had any physical ailments or medical issues that would

prevent him from performing the test and he stated " No". I directed Lloyd to a portion of a nearby parking lot that was level, free of debris, and well lit. I then explained and demonstrated each test to Lloyd. After receiving confirmation from him that he understood each test, I had him perform the test.

I then performed the Horizontal Gaze Nystagmus (HGN) test on Lloyd. I observed six out of six clues. During the instructional phase of the walk and turn test, Lloyd was swaying while standing and continued to spread his feet apart for balance. Lloyd then stepped out of the position 2 times and raised his arms above waist level to maintain his balance. Lloyd then separated his feet once again and remained standing with feet spread apart for several moments. Lloyd was reminded to stay in the instructed position several times, which he finally complied. During the test he missed heel to toe 9 times and stopped walking on his 9th step. Lloyd then failed to turn on the 9th step and continued to take 12 more steps. Once Lloyd reached the 12th step, he then jumped one time and turned around taken one large step. As Lloyd conducted his first 9 steps and continued with additional steps, he kept his arms raised above waist level and failed to keep to arms down by side as he was instructed to do so. During the one leg stand test, Lloyd raised his right foot. As Lloyd conducted the test he continued swaying and raised his arms above waist level to maintain balance. Lloyd then placed his foot down and was unable to keep his foot parallel to the ground. Lloyd then began to count but stopped at the number 2. Lloyd then raised his arms and looked at me nodding his head from left to right. Lloyd then attempted to continue the test by raising his right foot once again. Lloyd remained quiet as he raised his right leg and quickly placed it back on the ground. At this point Lloyd was advised he was under arrest, he was handcuffed then searched. I checked the rear compartment and placed Lloyd in my patrol unit. He was transported to headquarters for processing. Once at headquarters, I secured my weapon and all electronic items. I then removed Lloyd from my unit and searched the rear compartment again with negative results. The driver was positively identified as Johnnie G Lloyd Jr DOB [REDACTED] of 1116-B South Broadway, Camden City, NJ 08103. He was handcuffed to the bench in the booking area, where he was also Mirandized. I then read Lloyd the New Jersey Standard Statement form and he agreed to provide breath samples. Lloyd was tested utilizing the Alcotest 7110 MKIII-C which yielded a result of 0.00 % BAC reading. During the breath test, the mouthpiece was changed after each breath Lloyd provided. The reading was not consistent with his obvious state of severe impairment, so I requested a urine sample from Lloyd. I advised Lloyd of his right to refuse my request for a urine sample. Lloyd refused to provide a urine sample and stated " I shouldn't have to provide breath samples, for a cigar my boy gave me". I asked Lloyd again if he ingested any drugs and he stated " I'm not sure, I was just smoking at work with my boy". Lloyd then stated " I just need to leave home". Lloyd was later released to family friend and issued a motor vehicle summons for 39:4-50 (E19 000658).
