Wolfe advised me that he was helping his aunt with her bills when he noticed large checking withdrawals from her account. Wolfe stated that police responded to the residence on 1/10/19 in reference to another fraud case (Case number 19-1969) involving a Publishers Clearing House scam.

Today while at the residence Wolfe received a call from Melanie at PLS Check Cashing in Tuscon Arizona asking if it was ok to cash a check for \$4000.00. The check (check #632) was written from [REDACTED] Merrill Lynch Wealth Management account to a Robert Lisalba. [REDACTED] has never met Lisalba but he calls her on the phone and asks for money from her. Lisalba provided a sad story of financial trouble to [REDACTED] to get her to send the money.

I spoke with Melanie from PLS Check Cashing and asked her not to cash the check. She stated she would not cash the check and would hold it. Melanie stated she could not mail the check back to [REDACTED] but would turn it over to a law enforcement agency if requested. Melanie advised me that Lisalba has come back to the business several times today attempting to get the check back. I provided Melanie with the Pennsauken Police case number and contact information.

[REDACTED] also has been sending money to a Virginia Hess in Riverbank CA. Hess and an unknown male named Tony have been calling [REDACTED] and telling her their farm is in trouble. Since 12/03/2018 [REDACTED] has sent Hess and Tony approximately \$5000.00. [REDACTED] has never met either Hess or Tony and they just started calling her home asking for money. The male Tony called several times while I was on location. I attempted to obtain information from Tony but he hung up on me. Wolfe advised me that he also attempted to obtain information from Tony but he refused. Wolfe advised that all the subjects call [REDACTED] on her house phone [REDACTED] so he contacted the phone company and the number is being changed to [REDACTED] beginning 01/13/2019. [REDACTED] stated that Hess gave her number to Lisalba and that's how he started calling her. Incident forwarded to the detective division.
