Dear Requestor:

This letter is in reply to your correspondence seeking certain records pursuant to the Open Public Records Act ("OPRA"), N.J.S.A. 47:1A-1 to 47:1A-13, and the common law right of access to public documents. We appreciate your patience and understanding in awaiting our response.

Specifically, your request seeks the following:

"[A]ny records confirming whether Chief Christopher Battiloro of the Westfield Police Department was ever employed by, assigned to, or worked directly under the supervision of the Union County Prosecutor's Office in any official capacity. Specifically, I am requesting documentation reflecting the nature and duration of any such assignment, secondment, or employment, including dates of service and job title, if applicable. If such a relationship exists or existed, please include any available records confirming the length and type of the assignment."

Please be advised that this Office has no records responsive to your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you may challenge the decision of this Office to deny access by either instituting a proceeding in the Superior Court of New Jersey or filing a complaint with the Government Records Council ("GRC").
