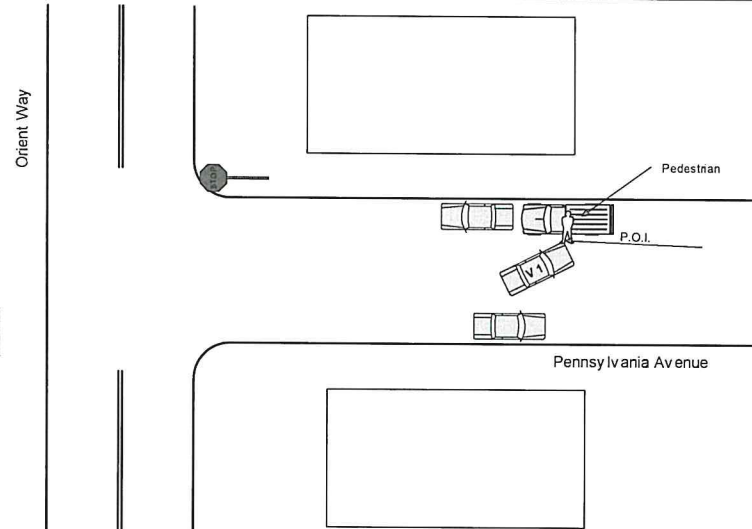

145. Crash Description/Narrative

The pedestrian and witness observed Vehicle 1 driving erratically eastbound on Pennsylvania Avenue just east of Orient Way. The pedestrian and witness stated that the driver of Vehicle 1 began to swerve in the roadway, narrowly striking parked vehicles on the south side of Pennsylvania Avenue. The driver of Vehicle 1 then abruptly turned the vehicle northbound towards the pedestrian, who was loading property into a pick up truck. The pedestrian stated that he was in the roadway securing the property into the truck when he was struck by Vehicle 1, which left the scene of the accident.

The incident and vehicle description was broadcast to patrol units. Moments later, Vehicle 1 was located and stopped by police nearby. While officers on scene were speaking with the driver of Vehicle 1, he initially did not recall striking the pedestrian or being involved in a crash that occurred moments earlier (LPD case #20-13292).
