Dear Ms. Cross,

The Wall Township Board of Education, (District) is in receipt of your emailed request that is dated June 1, 2023, wherein you requested record as follows:

“A copy of the e:mail and letter(s) sent from Adam Nasr sent to Ralph Addonizio, Joe Hall and Russell Gartz sent on 8/15/2021. The subject line should include and not be limited to "Letter to NJ.com".”

In response to your request, attached please find a copy of the requested email, consisting of one page. Portions of the record have been redacted as that information is in draft form and is protected by the Deliberative Process Privilege, noting that it was ultimately decided that the draft would not become a final document. Please see Ciesla v. NJ Dept. of Health & Senior Services, 429 NJ Super 127 and Libertarians for Transparent Government v. Government Records Council, 453 NJ Super 83.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Wall Township Board of Education to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ 08625, be-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
