The City of Hackensack ("City") records custodian received your Open Public Records Act ("OPRA") request on May 8, 2023. As such, the seven business day deadline to respond to your request is May 17, 2023. This response is therefore being timely submitted in accordance with New Jersey law. See N.J.S.A. 47:1A-5.

RECORDS RESPONSE: No responsive records found pertaining to a "list of all licensed laundromats in Hackensack" as the City of Hackensack does not maintain lists by business type.

The Fire Department would be able to generate a list with the below criteria per the Fire Official as their system does not have the capability to generate any citywide list by just business type. They keep records by the name of the business and would need the name and/or address of the laundromat you are seeking records for. Once you are able to provide that information, the Fire Department would be able to compile the records you are seeking. Please be advised, the City would not be able to provide contact information such as phone numbers or email addresses, only the mailing address of the current owner.
