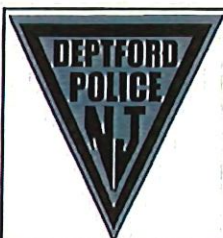

On 11/09/2025 at approximately 07:29 hours, I, P/O Casella #5289, was dispatched to 121 Weybridge Court, for a report of an intoxicated female having a psychiatric emergency. I responded priority two (2).

Upon my arrival, I spoke with the caller Jeffrey M. Defrehn (DOB : [REDACTED]). While speaking with Jeffrey, he explained that his wife, Colleen M. Silk (DOB: [REDACTED]) made suicidal statements to him and has been under the influence of alcohol over the span of multiple days. Jeffrey stated to me that Colleen said to him "I'm better off dead; I should just go kill myself" in addition allegedly making a "gun" shape with her fingers and putting it towards her head. Colleen also apparently attempted to leave the residence while exhibiting this behavior which also concerned Jeffrey.

I then spoke with Colleen outside, who immediately advised me that she was fine and that she did not want to hurt herself and was dismissive of the questions I was asking her and said she just wanted to be away from Jeffrey. I asked Colleen if she made mention Jeffrey of wanting to hurt herself, when she replied, "he just picks up whatever he wants". Due to the information provided by Jeffrey and Colleen's demeanor while on scene, I advised County

A copy of that form is attached to this report. I advised Colleen that she would need to be transported, and Colleen advised me that she was not going and that we would have to arrest her.
