The City of Hackensack ("City") records custodian received your Open Public Records Act ("OPRA") Ref. No. 26-449 request on March 10, 2026. As such, deadline to respond to your request is March 20, 2026. This response is therefore being timely submitted in accordance with New Jersey law. See N.J.S.A. 47:1A-5.

RECORDS RESPONSE: Records previously sent over on March 11, 2026. As per our conversation, the body worn camera footage was narrowed down to only P.O. Marza and P.O. Gibson.

For the responsive footage, you will be receiving a separate email Axon – Evidence.com where you will be able to download the footage via the Download link: [Click here for download]. The link will expire in 7 days, please download the files before March 26, 2026.

Redactions to the Arrest Reports provided were made pursuant to NJSA 47:1A-1 and 47:1A-3, along with associated judicial and GRC decisions in order to protect the legitimate privacy interests of the arrestees.

Pursuant to Executive Order No. 21, fingerprint cards, plates and photographs and other similar criminal investigation records which are required to be made, maintained or kept by any State or local governmental agency are exempt from disclosure, as such, arrest photographs have been redacted.

Non-public information including personal phone numbers, social security numbers, dates of birth, identification cards and other identifying documents have been redacted from the Body Worn Camera footage pursuant to N.J.S.A. 47:1A-1.1.

Your OPRA request is now deemed answered and closed.
