Incident Report



On March 21, 2025, at approximately 4:53 a.m. Teaneck Volunteer Ambulance Corp (TVAC), Teaneck Fire Department, Advance Life Support #213 (ALS) and I responded to Care One located at 544 Teaneck Road, Room 313a, [REDACTED]

Upon arrival, I spoke with the floor nurse, Mr. Tim Gonzales, [REDACTED], Mr. Anthony Gallucci. After several attempts to regain life, ALS reevaluated Mr. Gallucci and determined that Mr. Gallucci time of death was 05:23 a.m., which was pronounced by Dr. Kay of Englewood Medical Center.

I spoke with a CNN, Ms. Moureen Hutchinson, who reported at approximately 2:30 a.m. she had last seen Mr. Gallucci alive, talking and refusing to turn over to his side. At approximately 4:50 a.m. Ms. Hutchinson went to check on Mr. Gallucci and observed that he was unresponsive and not breathing.

Mr. Gonzales advised me that Mr. Gallucci had [REDACTED].

After speaking with medical staff, the death did not appear to be suspicious and it is believed that Mr. Gallucci passed away from his on going medical issues. Mr. Gonzales advised me that the facility contacted the family of Mr. Gallucci and advised that they would be responding to the facility.
