Please consider this a formal OPRA request for the unredacted Use of Force reports for incidents occurring in the calendar years 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015 and 2016 from each law enforcement department or agency that submits annual reports to your agency, as well as forms completed after an incident during those years in your agency.

We are entitled to these unredacted reports under N.J.S.A. 47:1A3(b) as a result of the state Supreme Court ruling on July 11, 2017, in the case *North Jersey Media Group v. Lyndhurst*.

The court wrote in its opinion, "The law calls for disclosure of 'the identity of the investigating and arresting personnel' and adds that the exception on which defendants rely 'shall be narrowly construed.'"

Under that ruling, the court also ruled that "OPRA's criminal investigatory records exception does not apply to records that are 'required by law to be made, maintained or kept on file.' N.J.S.A. 47:1A-1.1. As a result, the exemption does not cover Use of Force Reports, which the Attorney General requires officers to prepare after the use of deadly force."

Therefore, this request cannot be denied under the exemption of an "ongoing investigation" since they are required under the Attorney General's Use of Force Policy, which has "the force of law for police entities." (*NJMG v. Lyndhurst*)

If your agency chooses to deny, citing safety concerns, please provide a statement for each incident stating why officer's names "will jeopardize the safety of any person . . . or any investigation in progress" or "would be harmful to a bona fide law enforcement purpose or the public safety." (*NJMG v. Lyndhurst*)

If possible, please forward the requested information via email in an excel spreadsheet. However, if your agency only maintains these records as copies of the original Use Of Force forms, we will accept PDFs of those unredacted files.

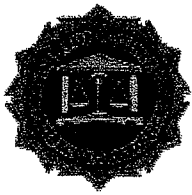

Dear Public Officers:

This is a OPRA request as well as a records request under the Common Law Right to Access of Records. This request is made as part of a news gathering effort and is not made for commercial purposes. I seek access to copies of all files, records, documents, electronic and paper which identify by name the Kearny, NJ Police officers allegedly facing disciplinary charges for their alleged culpability in missing evidence from the Kearny Police Department property room. Be advised that the 2006 New Jersey Law Revision Commission Final Report recommended amendments to N.J.S. 47:1A-10 of which were adopted by the legislature and states as follows: "Notwithstanding the provisions of P.L. 1963, c.73 (C.47:1A-1 et seq.) or any other law to the contrary, the personnel or pension records of any individual in the possession of a public agency, including but not limited to records relating to any grievance filed by or against an individual, shall not be considered a government record and shall not be made available for public access, except that:

an individual's name, title, position, salary, payroll record, length of service, date of separation and the reason therefor, and the amount and type of any pension received shall be a government record": [please see attached]

The public has a Common Law Right to know the names of the Kearny police officers involved, their titles position/rank and salary. Each of you as heads of your respective agencies has a duty to abide by the OPRA and to abide by and uphold and exhibit strict observance of the tenets of Common Law. Disclosure of the requested names of the officers facing disciplinary charges would help to restore residents faith, and the faith of Americans writ large in the justice system and police departments. Therefore, in the interest of the protecting the public from further violations of law and Breach of Duty, releasing the officer's names signals to the public that Kearny PD respects the community it serves and respects the Common Law Right to Know and Right to Access.

The right to know is sacrosanct and should not and shall not be suppressed as is expressly prohibited by both Common Law, state law and NJ Supreme Court precedent. As a representative of the media, this request is made on behalf of our viewers, as previously stated, for news gathering purposes and not for commercial purposes.
