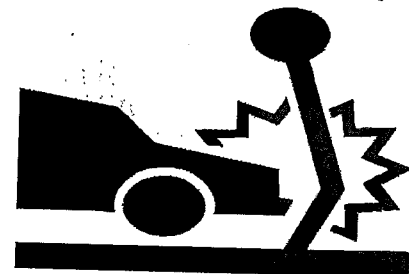

Background:

As to our first request, we have information that Detective Christian Acevedo may have been arrested by New Jersey State Police from the Woodstown Barracks a few months back and would like to know if this is true. Since the State Police are notoriously slow in responding to OPRA requests, we are requesting the CDR (complaint) from Bridgeton because (assuming that Acevedo actually was arrested), we believe the City would have probably received a copy of the CDR on account of Acevedo being a City employee.

As our second request, we would like the disclosable personnel information specified in N.J.S.A. 47:1A-10 regarding Christian Acevedo. 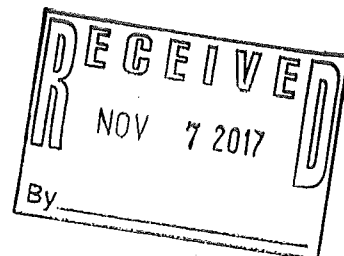

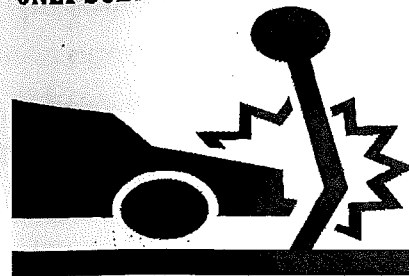
