To Whom It May Concern:

Under the New Jersey Open Public Records Act, N.J.S.A. 47:1A-1 et seq., I am requesting an electronic copy of public records concerning animal abuse incidents in the state of New Jersey that have resulted in the death of an animal or a person being charged with the crime from January 1, 2009 through December 31, 2014.

If necessary, I request any tables or codes that are needed to understand any data that might be in the records I am requesting.

Additionally, I request that the records are sent electronically via email or any other compressed format. I also request that the data is sent to me at no charge because of this format. However, please inform me if the records are to be sent in another arrangement other than electronically, or if there will be a cost at all.

The New Jersey Open Public Records Act requires that there is a response time of seven business days. If access to these records should exceed the given seven business days, I request that you please contact me with any information about when or how I might receive these records.

If for any reason at all that my requests for these records are denied, please notify me of this as soon as possible. Additionally, please send an explanation as to why my request was denied, and at what points specifically.

I am a senior journalism student at Rider University in Lawrenceville, New Jersey and I am making the request for my in-depth reporting class.

If I was unclear about anything in my request, I would be more than

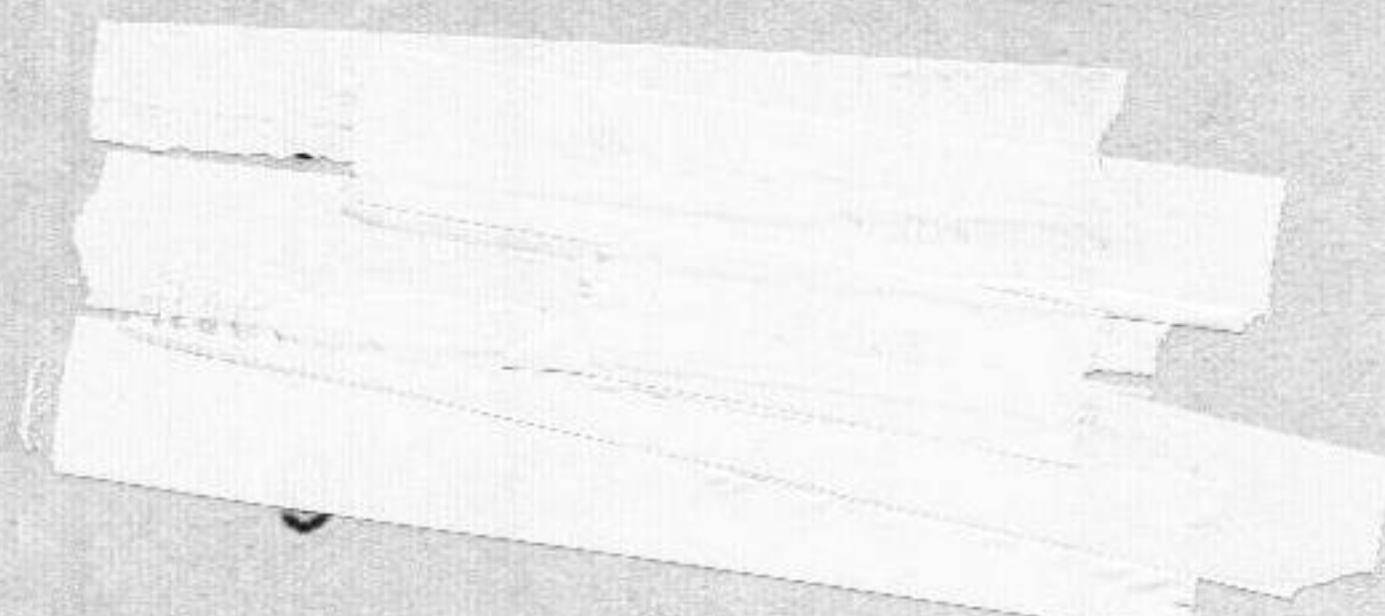
