145 Crash Description/Narrative

V#1 was traveling West on Jones Road. V#1 reversed and started to travel East heading backwards. As V#1 was taveling backwards, it struck the wooden fence in front of 2 Jones Road, Forked River, NJ, causing damage to the fence.

D#1 stated that she was traveling West on Jones Road. She stated that as she approached the intersection of Jones Road and Route 9, she realized that she should have turned into the parking lot of the Lacey Township Community Hall to get to the traffic light at Lacey Road and Route 9. She stated that she put her car in reverse and started to travel backwards on Jones Road with the intention of turning into the parking lot of Community Hall and in doing so, struck the fence.

Witness #1, Jesse Violante, 609-618-6366, stated that he observed V#1 traveling West on Jones Road. He stated that V#1 stopped and paused for a few seconds before traveling in reverse and striking the fence located at 2 Jones Road.

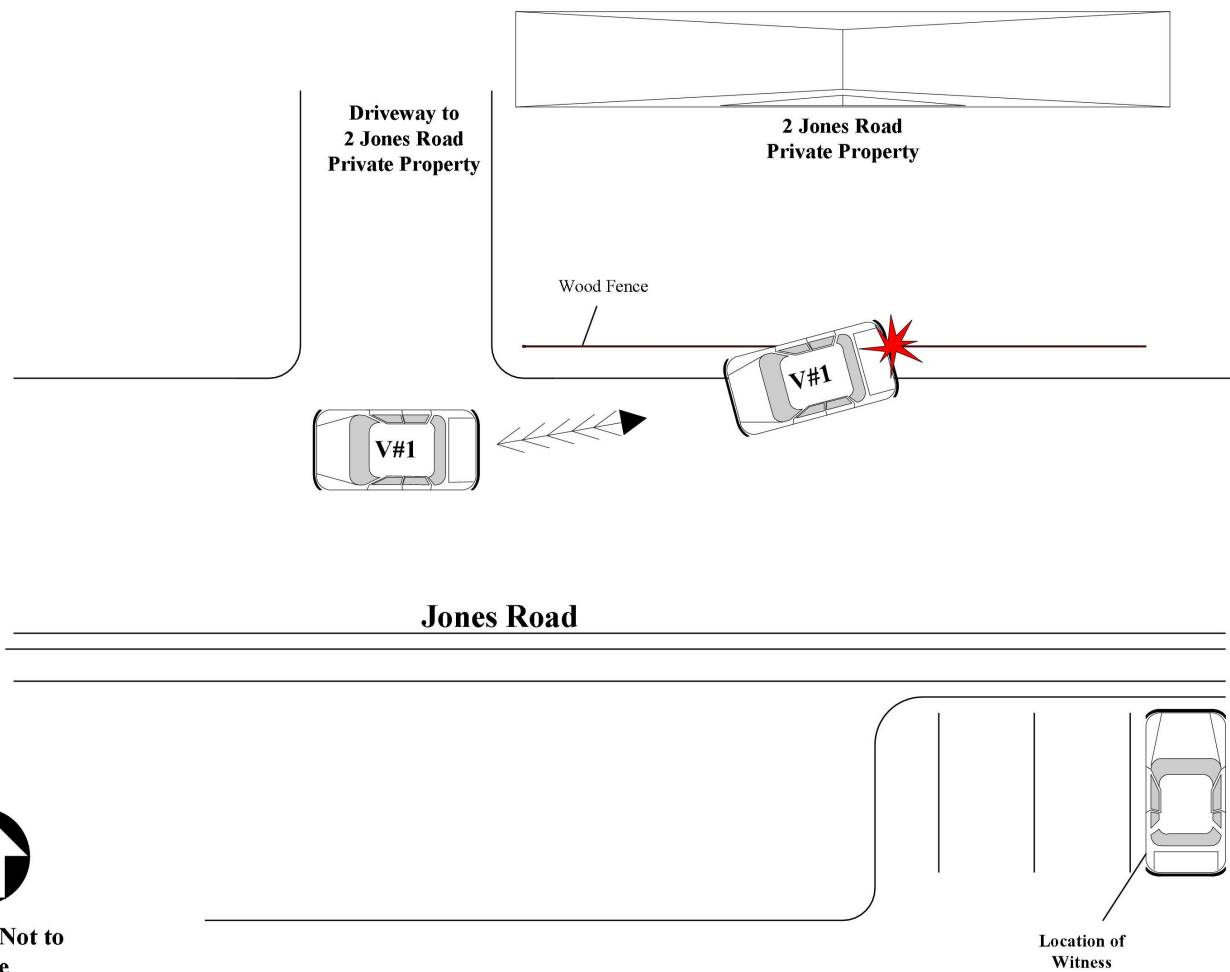
