145 Crash Description/Narrative

Driver 1 stated he had just finished unloading a delivery and was exiting the parking lot of 701 Lacey Road. He stated he backed into a parking space in order to turn around and exit the lot. When he began to drive forward the under ride bar of Vehicle 1 struck Vehicle 2. Vehicle 2 was legally parked in a space at 701 Lacey Road. Vehicle 2 sustained damage to the driver's side rear fender and the rear bumper was torn from the vehicle. Crash investigation revealed driver inattention on the part of Driver 1 was a contributing factor in the crash.

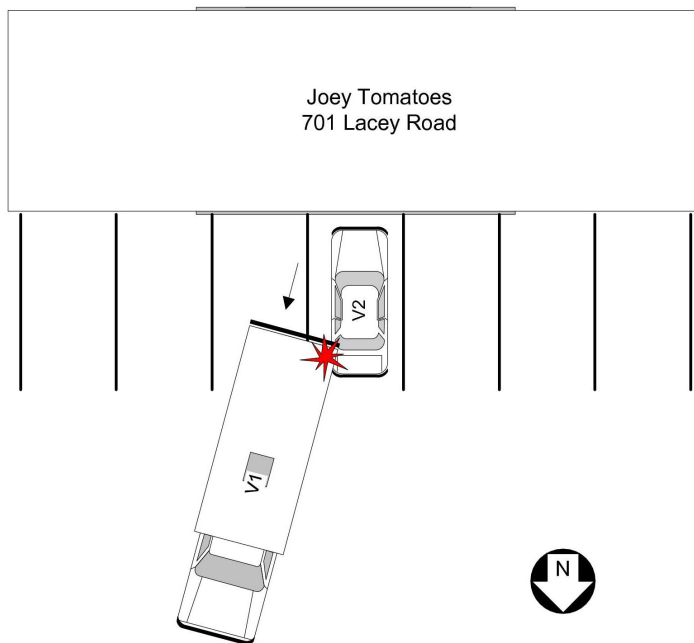
