

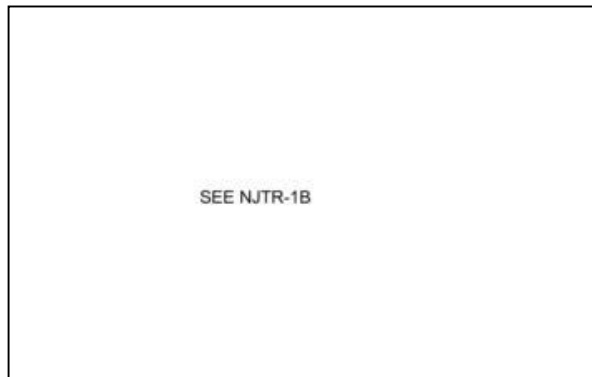

145 Crash Description/Narrative

V1 was backing from his driveway on Hoyt Street, when V1 was struck in the center of the roadway by a eastbound backing V2. The crash caused minor damage to the rear of V1, and the front, passenger's side of V2.

Further police investigation revealed that driver inattention and backing unsafely committed by D2 were the main contributing factors leading to the crash.

****Surveillance footage obtained captured the incident, which was copied to a disc and submitted into police property records. In the footage, V2 is observed passing the driveway of 1036 Hoyt Street, traveling west (in drive), which prompts V1 to back from his driveway at 1036 Hoyt Street as the roadway was clear. As V1 is 3/4 out of his driveway, V2 proceeds to back eastbound up Hoyt Street, attempting to back into an adjacent driveway. This prompted V1 to come to an abrupt stop, in an attempt to avoid the crash by quickly shifting into, "Drive." V2 continued to back, causing the Front, Passenger's Side of V2 to strike the rear of a stopped V1.****

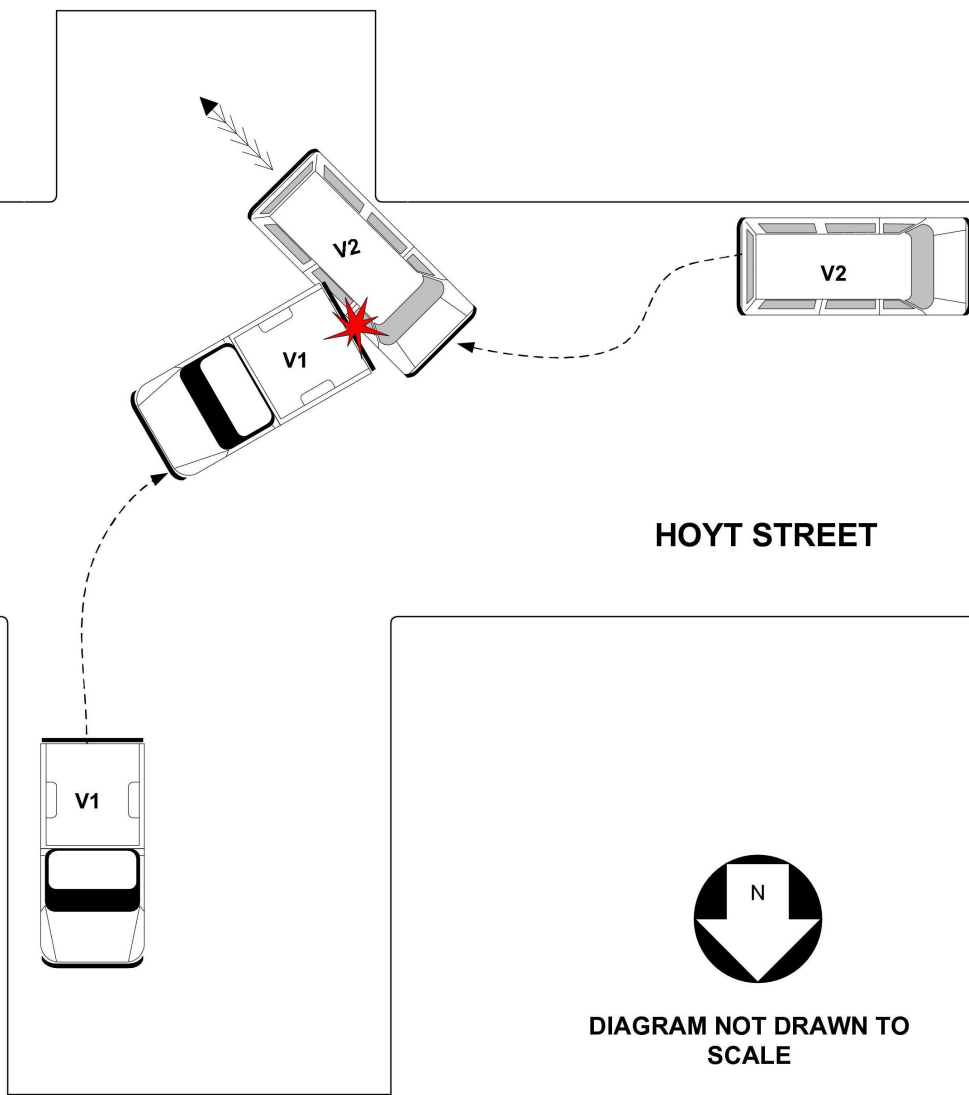
